The National Library of the Philippines (NLP) through the authorized appropriation for **FY 2021** General Appropriation Act (GAA) intends to apply the sum **Two Million Six Hundred Sixty Six Thousand Seventy Pesos (Php2,666,070.00)** being the Approved Budget Contract (ABC) to payments under the contract for the **ESUBSCRIPTION FOR THE NATIONAL LIBRARY OF THE PHILIPPINES** under **Public Bidding No. 20-11**. Bidding will be through **LOT BIDDING**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The NLP now invites bids for the **ESUBSCRIPTION FOR THE NATIONAL LIBRARY OF THE PHILIPPINES**. Delivery of the goods is required within 15 calendar days upon receipt of Purchase Order. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible to bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act. Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
