SUBJECT : "HIGHER EDUCATION AND HUMAN RESOURCE DEVELOPMENT IN THE ASIA-PACIFIC FOR THE 21ST CENTURY: A WORLD CONGRESS" ON 23-25 JUNE 1997 AT THE PHILIPPINE INTERNATIONAL CONVENTION CENTER (PICC), PASAY CITY

In accordance with the pertinent provisions of Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1994," and by virtue of the appropriate Resolution of the Commission en banc and in consonance with Presidential Proclamation No. 874 declaring 23-27 June 1997 as National Higher Education Week and designating the Commission to lead in its observance, the Commission will be holding the "Higher Education and Human Resource Development in the ASIA-PACIFIC for the 21st Century: A World Congress" on 23-25 June 1997 at the Philippine International Convention Center, Pasay City.

Co-sponsored by the Department of Science and Technology, the Department of Foreign Affairs, the Department of Tourism, the Department of Labor and Employment and the Technical Education and Skills Development Authority, and cooperated by the UNESCO Principal Regional Office for Asia and the Pacific, SEAMEO Regional Center for Higher Education, ASEAN University Network, Association of Universities in Asia and the Pacific, International Association of University Presidents, British Council, Philippines, the Philippine American Educational Foundation, and the Association of Southeast Asian Institutes of Higher Learning, the Congress aims to internationalize higher education.

Presidents/Heads and senior faculty members and officials of public and private Higher Education Institutions (HEIs) in the country, Directors and Division Chiefs of the Commission at the central and regional offices, and officials of educational associations may attend the said Congress. Participants registering and paying before 31 January 1997 shall be charged P4,500.00 only. However, payments after this cut-off date shall be P5,000.00. Registration fees may be paid in cash or checks. A P100.00 processing fee shall be added to out-of-town checks. Check payments may be done on a bank-to-bank transaction to: Land Bank of the Philippines, Pasig Capitol Branch, Shaw Blvd., Pasig City, Trust Account # 0672-1027-74. Registration and payment can be done either in the central or regional offices of the Commission.

To enable the Commission to estimate the number of participants attending the Congress for purposes of logistics planning, advance registration may be done on 27 December 1996.

Registration fees and other expenses incidental to the attendance of Congress participants from the Commission, from SUCs, from CHED-supervised HEIs and from Local Universities and Colleges may be charged against local funds, subject to the usual accounting and auditing rules and regulations. Participants from private HEIs may make the necessary arrangements with their respective institutions.
