SUBJECT: AMENDMENTS TO THE CHED MEMORANDUM ORDER NO. 07 ENTITLED "IMPLEMENTING RULES AND REGULATIONS ON THE SHARING SCHEME OF THE P75M FUND FOR PRIVATE HIGHER EDUCATION INSTITUTIONS (PHEIs) COMPUTERIZATION PROGRAM AUTHORIZED UNDER REPUBLIC ACT (RA) NO. 8174, OTHERWISE KNOWN AS THE 1996 GENERAL APPROPRIATIONS ACT (GAA)"

In view of the deduction by 16.2% for the reserved leaving only an available amount of P62.833M, the subject Implementing Rules and Regulations is hereby amended, thus:

- Maintenance and Other Operating Expenses (MOOE) in number 1.1 thereof is hereby increased from P11.25M to P14.666M which is allocated for the trainings and services.
- The Capital Outlay (CO) in number 1.2 thereof is hereby reduced from P63.75M to P48.167M.
- The basic share in number 3.1 and the additional amount of P37.5M from Higher Education Development Fund (HEDF) in number 10 thereof have been re-computed, thus:
