SUBJECT : CHED PRIORITY COURSES FOR AY 2005-2006

In accordance with the pertinent provisions of Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1995," and based on the result of the inter-agency meeting conducted with representatives from the Department of Labor and Employment (DOLE), National Economic Development Authority (NEDA), Philippine Association of State Universities and Colleges (PASUC), Coordinating Council for Private Educational Associations (COCOPEA) and Technical Education and Skills Development Authority (TESDA), the following are the identified priority courses for AY 2005-2006, where in-coming grantees of CHED-administered student financial assistance programs (STUFAP) shall be directed to enroll.



All other provisions of the said CMO, particularly the qualifications of HEIs eligible to accept or enroll CHED scholars shall remain the same and in effect.


