The Category of A(t) granted herein shall be for six (6) years effective November 15, 2007 to November 16, 2013. The Categories of B and C shall be for five (5) years, effective November 15, 2007 to November 16, 2012, provided that the concerned institutions may request an earlier revisit but not within the first three (3) years.

Institutions that have been assessed under the IQuAME Framework shall qualify for any form of benefits/interventions that the Commission may provide.
