In accordance with the pertinent provisions of Republic Act (RA) 7722, otherwise known as the "Higher Education Act of 1994" and Pursuant to CHED Memorandum Order (CMO) No. 15, s. 2005 entitled "Institutional Monitoring and Evaluation for Quality Assurance of all Higher Education Institutions in the Philippines," and CMO No. 16 2005 known as the "Implementing Rules and Regulations," and by virtue of CEB Resolution No. 363, series 2008, all institutions assessed under the IQuAME Framework in the 2<sup>nd</sup> quarter of 2007 up to June 2008 are hereby informed of the result of the IQuAME assessment.

The *Lysceum of Batangas, Batangas City* is due for revisit within 12 months from the date of issuance of this CMO, for final determination of its Category. In addition, the following Institutions are to be closely monitored by the CHED Regional Offices.

The Category of A(t) granted herein shall be for six (6) years effective August 15, 2008 to August 16, 2014. The Category B shall be for five (5) years, effective August 15, 2008 to August 16, 2013, provided that the concerned institutions may request an earlier revisit but not within the first three (3) years. However, an early revisit may be granted to institutions with Category B and C including those identified in CMO No. 58, s. 2007, provided the CHED Regional Offices shall recommend and attest to the improvements within the institutions based on the earlier findings of the IQuAME Assessment Team.

These Institutions that have been assessed under the IQuAME Framework shall qualify for interventions and other forms of assistance that the Commission shall provide subject to availability of funds.
