DR. JOSE P. RIZAL MEMORIAL FOUNDATION FUND CAMPAIGN

To: The Director of Public Schools,
The Director of Private Schools,
The Director of Vocational Education, and
the Coordinator of State Colleges and Universities.

1. In 1968, several outstanding government officials and civic leaders headed by General Carlos P. Romulo, Dr. Pablo C. Samson, and Dr. Andres L. Abadja, established a civic, non-profit organization, the "Dr. Jose P. Rizal Memorial Foundation", which has a counterpart organization in the United States, the "Dr. Jose P. Rizal-General Douglas MacArthur Memorial Foundation".
2. One major project of the Foundation is the establishment of the Dr. Jose P. Rizal National Medical Center in Pasmarilao, Cavite, which will serve as a nucleus and national headquarters for community medical research, preventive medicine, and sanitation projects in line with the Medicine Program of the Administration.
3. Since 1968, funding of various projects of the Foundation has come mainly from membership dues, financial assistance from its counterpart in the United States, and donations from altruistic individuals who believe in the cause. To further boost this noteworthy project, the Office of the President of the Philippines has issued Presidential Proclamation No. 1383, authorizing the extension of the nationwide foundation fund campaign to June 30, 1975.
4. A project of this magnitude will be successful only to the extent that it has wide support. Schools at all levels are therefore requested to extend not merely support but also full cooperation in this drive so that the Foundation goals will be realized. Donations or contributions, which are tax deductible, should be sent direct to the Foundation at KMC Building, 1952 Escoda St., Manila.

PROCLAMATION NO. 1369

EXTENDING URGENCE NO. 1270, ALIAS MEMORIAL FOUNDATION UP TO
JUNE 30, 1975.

WHEREAS, the Dr. Jose F. Rizal Memorial Foundation was authorized under Proclamation No. 1270 dated February 5, 1974, to conduct a fund drive from February 23 to June 19, 1974, for the Dr. Jose P. Rizal Medical and Research Center in the resettlement community at Guadalupe, Cavite;

WHEREAS, Proclamation No. 1270 was subsequently issued extending said fund campaign up to December 31, 1974; and

WHEREAS, the Foundation needs more time for the conduct of its drive to enable it to carry out its project;

NOW, THEREFORE, I, ALFREDO M. ABADIA, Executive Secretary, by order of His Excellency, FERNANDO E. MARCOS, President of the Philippines, do hereby extend the aforesaid fund campaign period up to June 30, 1975.
