THE DEC SCHOLARSHIP COMMITTEE

To the: Bureau Directors
Regional Directors
Coordinator, State Colleges and Universities

1. Under the reorganized setup, the Department of Education and Culture handles all the scholarship programs heretofore handled by the defunct bureaus of the Department.

1.1 A DEC Scholarship Committee, is hereby organized as follows:

1.2 The functions of the Committee are the following:

- 1.2.1 To review the scholarship papers of regional nominees for final screening and selection;
- 1.2.2 To take charge of all matters related to the various local scholarship programs, except those now being administered by the National Scholarship Center;
- 1.2.3 To review and re-study the existing scholarship programs in relation to the present needs of the system and to make recommendations for their improvement, modification, or revision and corresponding Memoranda of Agreement;

1.2.4 To make representations with colleges and universities concerned with regard to the improvement, modification, or revision of scholarship programs and the subsequent changes in the Memoranda of Agreement.

1.2.5 To give guidance sessions and proper direction to the participants whenever such become necessary.

2. The Chairman of the DSC Scholarship Committee is authorized to sign for the Secretary of Education and Culture communications to the field pertaining to scholarship.

3. A uniform ruling on scholarship privileges for all participants in the various scholarship programs has been set, to wit:

3.1 P200 for the monthly stipend for the duration of the scholarship.

3.2 P300 for book allowance or P150 per semester drawable at the beginning of each semester.

3.3 Two-way first class land or boat transportation expenses from the participants' station to Manila and return.

4. The sponsoring college or university is to bill the Department of Education and Culture for the participants' tuition fees and other miscellaneous expenses in connection with registration or enrollment.

5. Scholarship committees by levels should be organized by the staff Bureau to assist the DSC Scholarship Committee.

6. Division scholarship committees should submit their nominees to the Regional Director for notation and submittal to the DSC Scholarship Committee, Manila.
