**AUTHORIZING ATTENDANCE AND PARTICIPATION IN THE SERIES
 OF REGIONAL SEMINARS SPONSORED BY THE PERSONNEL
 OFFICERS ASSOCIATION OF THE PHILIPPINES (POAP)
 THRU THE REGIONAL CHAPTERS.**

The Personnel Officers Association of the Philippines (POAP), through its regional chapters, will sponsor a series of five-day regional seminars, with the cooperation and technical assistance of the Civil Service Commission, on the theme "The New Orientation."

These regional seminars will enable officers and employees of the government to participate in the exchange of pertinent information and assess and redirect their contributions to make more effective their role as instruments in the attainment of the policies of the New Society.

National and local offices are hereby authorized to route back-to-back five (5) airfares of officials and employees particularly those who are members of the POAP, to the seminar listed below on official business with reasonable expenses for transportation, per diem and subsistence fees, chargeable against the appropriations of their respective offices, in accordance with the provisions of Presidential Decree No. 344 dated November 26, 1973, as implemented by CSC General Circular No. 127 dated November 27, 1973, subject to the availability of funds and the usual accounting and auditing requirements, as an exception to Memorandum Circular No. 593 of this Office dated August 1, 1972.
