SEMINARS ON THE IMPLEMENTATION OF THE REVISED
SECONDARY SCHOOL CURRICULUM AND ON THE
STRATEGIES IN THE TEACHING OF SECONDARY
SCHOOL SUBJECTS TO BE OFFERED AS CREDIT
COURSES FOR SUMMER 1976 AT THE BAGUIO
VACATION NORMAL SCHOOL

Chiefs of Services and Heads
of Units

1. Credit courses for the Seminars on the Implementation of the Revised Secondary School Curriculum and on the Strategies in the Teaching of Secondary School Subjects will be offered at the Baguio Vacation Normal School during the April 5 - May 14, 1976 summer term. The two (2) seminars will be under the joint auspices of the Bureau of Secondary Education and the Baguio Vacation Normal School.
2. There will be one and a half (1½) hours of formal classwork for each seminar with participants earning three (3) units per seminar attended. Both seminars will be credited as cognates or as part of the Administration-Supervision specialization courses for either a Master of Arts or Master of Education degree.
3. The Seminar on the Revised Secondary School Curriculum aims to:
 - a. Acquaint the participants with the DEC policies, and the philosophies and theories governing curriculum development particularly as they affect the Revised Secondary School Curriculum.

- b. Formulate agreements on what will constitute the general educational content, methodologies or approaches for the effective implementation of the Revised Secondary School Curriculum.
- c. Learn the latest evaluative techniques and how to apply them in assessing the effectiveness of the Revised Secondary School Curriculum.
- d. Suggest measures for the further improvement of the Revised Secondary School Curriculum.

4. The Seminar on the Strategy in the Teaching of the Secondary School Subjects aims to:

- a. Familiarize participants with the latest methodologies or approaches in the teaching of the secondary school subjects.
- b. Apply modern curriculum theories to the improvement of subject-matter content for the secondary level.
- c. Formulate educational measures for each subject area to gear the Revised Secondary School Curriculum to the values of the New Society.

5. Participation in the two (2) seminars is open to interested school officials, administrators and/or supervisors, provided they possess at least a Bachelor's degree in Education or its equivalent and provided furthermore that they are willing to use their personal funds for expenses for their attendance in the two (2) seminars.

6. One (1) participant from the Bureau of Elementary Education, Bureau of Secondary Education, Bureau of Higher Education and the National Research and Development Center for Teacher Education and one (1) from each of the twelve (12) BEC regions are, however, authorized to attend the two (2) seminars with expenses for their participation charged against funds of their respective offices, subject to the usual accounting and auditing regulations. Priority in the selection of official participants should be given to those involved in curriculum development and to those in a position to extend leadership in curriculum matters.

7. Participants are requested to bring general curricular materials, action programs on the secondary school level, and other related materials.
