ANNOUNCING THE ESTABLISHMENT OF REGION IV-A  
OF THE DEPARTMENT OF EDUCATION AND CULTURE

1. This is to announce the establishment of Region IV-A of the Department of Education and Culture, hereafter to be referred to as DEC Region IV-A, comprising the following provincial and city school divisions:

2. DEC Region IV-A was created under P.D. 879 out of the original Region IV, which now comprises the cities of Manila, Quezon, Caloocan, Pasig and the twelve (12) municipalities of Rizal and Valenzuela (Bulacan). DEC Region IV is presently constituted into four (4) city school districts of Metropolitan Manila, as follows:

3. The regional office of DEC Region IV-A is located at the second and third floors of the Teachers Building of the Philippine Public School Teachers Association (PPSTA), Banawe Street, Quezon City. The headquarters for Region IV remains in its present location.

4. DEC Region IV-A will be operational starting July 1, 1977. In the meantime, efforts should be exerted towards filling the items in accordance with the approved staffing pattern, the transfer of records, and the necessary arrangements for the transfer of funds allotted to Region IV-A under P.D. No. 1050 presently administered by Region IV.
