PROCLAMATION NO. 1540

AUTHORIZING THE PHILIPPINE MENTAL HEALTH ASSOCIATION, INC., TO CONDUCT  
A NATIONAL MEMBERSHIP, EDUCATIONAL AND FUND CAMPAIGN DURING  
THE PERIOD FROM FEBRUARY 1 TO DECEMBER 31, 1977

WHEREAS, the Philippine Mental Health Association, Inc., is a non-profit organization deeply involved in the preventive, curative and rehabilitative aspects of mental illness;

WHEREAS, said organization during its two decades of existence has demonstrated the value and importance of its services;

WHEREAS, the association needs more members in the movement and funds to broaden the scope of its preventive and rehabilitative projects;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by law, do hereby authorize the Philippine Mental Health Association, Inc., to conduct a national membership, educational and fund campaign during the period from February 1 to December 31, 1977. I call upon all citizens and residents of the Philippines to assist in this humanitarian endeavor by giving generously of their means.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.

Done in the City of Manila, this 18th day of May, in the year of Our Lord, nineteen hundred and seventy-seven.
