NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by law, do hereby authorize the Philippine Mental Health Association. Inc., to conduct a national
membership, educational and fund campaign during the period from February 1 to December 31, 1977. I call upon all citizens and residents of
the Philippines to assist in this humanitarian endeavor by giving generously of their means.
