1977 ANTI-TB FUND CAMPAIGN QUOTA ALLOCATIONS
AND MANNER OF REMITTANCE

To: Bureau Directors
Regional Directors
Coordinator, State Colleges and Universities
Schools Superintendents

1. As announced in Department Memorandum No. 120, s. 1977, His Excellency, the President, under Proclamation No. 1622, authorized the Philippine Tuberculosis Society to conduct the 1977 Educational and Fund Campaign from February 15 to December 31, 1977.
2. The campaign organization follows the same structural pattern as the 1976 Fund Drive. All schools, colleges and universities, public and private, are again placed under the Educational Institutions Division. However, it is given a new quota of ₱200,000.
3. A report on the 1976 Fund Drive which also indicates the 1977 quota allocations for all regions, including that for state colleges and universities, is enclosed. Regional directors, in turn may correspondingly modify the 1976 quota allocation of the various provincial and city divisions under them.
4. Reference is hereby made to the 1973 and 1976 Guidelines of the Fund Campaign, attention being invited to the possible overlap in collection accreditation in the campaign in the local level. Collections from teachers and school children at the revised quota rates of ₱2.00 per class in the elementary level and ₱5.00 per class in the secondary school and the collegiate levels accrue to the Educational Institutions Division and to no other.
5. Attention is likewise invited to the manner of remitting collections. The check or money order from school divisions is drawn in favor of the Philippine Tuberculosis Society, Inc. and transmitted to the Regional Director's Office, which, in turn will consolidate the remittances as these are received, indicating in summary form the source of the remittance (school division) and the amount. These will be transmitted to the Division Chairman, Undersecretary Maricela Albarracin, DEC, Manila.

6. Campaign fund receipts will be provided by the Anti-TE Society, Inc.

7. Immediate dissemination of this Department Memorandum to all school officials concerned is requested.
