Submission of Data on YCAP Coordinators

1. The National YCAP Coordinating Unit is presently preparing its YCAP Fact Book which shall contain, among others, the names and addresses of school coordinators involved in the Youth Civic Action Program, for ready reference.

2. In this connection, this Office desires that a list of all the YCAP coordinators in the region, including those in the state and private colleges and universities, as well as YCAP Form 7 (sample form attached), duly accomplished in triplicate by every coordinator, be submitted to the National YCAP Coordinating Unit, Department of Education and Culture, Arroyo, Manila, on or before August 15, 1977.

3. The regional YCAP coordinator shall prepare the list of YCAP coordinators in the regional office and in the state and private colleges and universities. The division YCAP coordinators shall prepare the list of the YCAP coordinators in the division offices, the districts, and the schools, to be submitted to the National YCAP Coordinating Unit through the regional office.

4. It is desired that this Department Memorandum be given preferential attention.
