SCHOOL ACTIVITIES FOR CONSUMERS' PROTECTION
WEEK - OCTOBER 23-29, 1977

To: Bureau Directors
Regional Directors
Coordinator, State Colleges and Universities
Schools Superintendents

1. Consumers' Protection Week will be observed from October 23 to 29, 1977, conformably to Presidential Proclamation No. 322, dated March 1, 1977. In this connection, the Department of Education and Culture, as member of the present Consumers' Protection Week Celebration Committee, is holding a slogan contest based on this year's theme "Consumers' Protection Through Law."
2. The slogan should be in Filipino or in English and open for all school levels and out-of-school youth. It should reflect the theme of the celebration as well as the rationale for Presidential Proclamation No. 322.
3. Prizes will be as follows: ₱500, ₱300 and ₱100 will be given to the first, second and third places in each category, respectively. In addition there will be consolation prizes of ₱50 for the next ten best slogans from other categories.
4. The slogan should consist of not more than ten words. Each entry should be submitted in typewritten form, double space, and should bear the name of the contestant, his school division and region not later than October 15, 1977, to the address below.
