DEPARTMENT MEMORANDUM

JAPANESE GOVERNMENT TO SUBSIDIZE PROJECTS IN COMMEMORATION
OF 1970 JAPAN WORLD EXPOSITION

To: Bureau Director,
Regional Directors
Chief of Services and Head of Units
Coordinator State Colleges and Universities
Schools Superintendents

1. In commemoration of the 1970 Japan World Exposition, the Japanese Government under the Commemorative Association for the Japan World Exposition (1970), is subsidizing projects which are considered to further the theme of the Exposition, "Progress and Harmony for Mankind."

2. Statements of Request for such grants for the 1978 fiscal year will be accepted on the basis of the following:

a. Projects eligible for support -

- (1) Projects contributing to international cultural exchange and friendship.
- (2) Projects relating to international cooperation in the scholarly and educational fields.
- (3) International projects concerned with the education and development of youth.
- (4) International projects concerning medicine, health, hygiene and social welfare.
- (5) International projects concerning the conservation of human environment.

b. Corporate status entitled to support -

- (1) Foundation
- (2) Corporate person
- (3) Corporation with de facto status of (1) or (2) and
- (4) Foreign corporation with corresponding status in respective country.

c. Amount of assistance -

As a general rule for one project the amount of assistance will not be more than Y30 million and will not be less than Y1 million.

d. Assistance rate -

Financial assistance rendered to a project is determined at the rate of 50 percent or less of the total budget of the project.

In the following cases, however, it is possible to render assistance for total requirement:

- (1) When the university, institution or museum in foreign countries purchases books;
- (2) When the university or institute purchases scientific equipment; and
- (3) When the applicants have exceptional reasons.

e. The projects listed in a must be carried out during the following period:

- (1) Commencement date: On or after April 1, 1978
- (2) Completion date: On or before March 31, 1979

f. Request procedure -

- (1) Documents to be submitted: "Statement of Request for Grant."
- (2) Request must be filed with the Office in (3) during the period: from September 2, 1977 to October 31, 1977
