AUTHORIZING THE FOUNDATION FOR YOUTH DEVELOPMENT
IN THE PHILIPPINES TO CONDUCT A NATIONAL
EDUCATIONAL AND FUND CAMPAIGN

To: Bureau Directors
Regional Directors
Chiefs of Services and Heads of Units
School Superintendents

1. Inclosed is Presidential Proclamation No. 1688 dated October 26, 1977, authorizing the Foundation for Youth Development in the Philippines, Inc., to conduct a national educational and fund campaign during the period from November 1, 1977 to October 31, 1978.
2. This Office strongly endorses this fund campaign. It is worth mentioning that the DDC and the FYDF jointly operate the growing chain of Educational Centers for Young Citizens Producers (ECYCP) two of which are now in operation at Bayambang, Pangasinan, and at Pili, Camarines Sur respectively.
3. It is requested that efforts be exerted to have school officials, teachers, faculty members, other school personnel, students and pupils of all schools, colleges, and universities, give liberally to the Foundation.
4. Remittance from each superintendent of schools shall be in check or money order drawn in favor of the Foundation for Youth Development in the Philippines, Inc. (FYDP) 1977 Fund Campaign and transmitted to the Regional Office, c/o the Regional Director who, in turn, shall transmit said check or money order to the Department of Education and Culture, c/o Dr. Narciso Albarracin, Campaign Vice-Chairman. In every case, the transmitted letter should indicate in summary form the sources of the collection to enable this Office to keep tab of the progress of the campaign. The superintendents of schools may indicate quotas for collection which shall not exceed ₱1.00 per teacher or ₱2.00 per class.

PROCLAMATION NO. 1608

AUTHORIZING THE FOUNDATION FOR YOUTH DEVELOPMENT IN THE PHILIPPINES, INC., TO CONDUCT A NATIONAL EDUCATIONAL AND FUND CAMPAIGN DURING THE PERIOD FROM NOVEMBER 1, 1977 TO OCTOBER 31, 1978.

WHEREAS, under the "Educational Development Decree of 1972," one of the declared policies of the government is to assure the maximum participation of all the people in the attainment and enjoyment of the benefits of accelerated economic development and social progress;

WHEREAS, literacy and socio-economic growth are closely interrelated;

WHEREAS, functional literacy promotion, integrated with the overall national development plan, is the most practical and effective approach for the training and mobilization of our human resources so that they can support intelligently the thrust of national development under the New Society; and

WHEREAS, the combined efforts of the government and private agencies to implement the fundamental duty of un-uttering our illiterates from ignorance, poverty and fear to give them dignity and equal opportunities and to enable them to participate creatively in nation building, can succeed only if the whole nation extends maximum moral and financial support;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by law, do hereby authorize the Foundation for Youth Development in the Philippines, Inc., to conduct its fourth national educational and fund campaign during the period from November 1, 1977 to October 31, 1978.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.

Done in the City of Manila, this 26th day of October, in the year of Our Lord, nineteen hundred and seventy-seven.
