GUIDELINES ON THE USE OF UNIFORM  
ID'S WITH DEC-BOE MARKINGS

To: Bureau Directors  
Regional Directors  
Coordinator, State Colleges and Universities  
School Superintendents  
Heads of Private Schools, Colleges and Universities

1. To enable the students to get the full benefit of reduced fares in public conveyances, the following guidelines on the use of "Uniform Identification Cards for Students with Department of Education and Culture and Board of Transportation (DEC-BOE) Markings" prescribed in Department Memorandum No. 273, s. 1977, are hereby issued: 1

- a. Students without ID cards bearing DEC-BOE markings may be refused the privilege of reduced fares in public utility vehicles. Students with ID cards shall not only enjoy the student discount privilege but should report any operator whose conductors refuse to grant the discount.
- b. The implementation of this project will start immediately in all schools, colleges, and universities in Metro Manila.
- c. For uniformity and economy, this ID will also serve as official school ID for all students in public schools.
- d. This ID shall remain valid unless revoked by the Secretary of Education and Culture and the Chairman of the Board of Transportation or recalled by the issuing school authorities.

- e. The official DLG-BOE ID is provided with plastic jacket and safety pin and may be bought at P2 per unit. Lost ID cards may be replaced at the same cost.
- f. All orders for IDs shall be placed only with the Board of Transportation, Scout Puyes Street, Quezon City.
- g. To insure early implementation of this project, schools are requested to advance the corresponding amounts and collect the same from the students concerned under their registration and enrollment at the beginning of school year 1978-1979.
- h. This ID should be surrendered to the issuing school authorities upon termination of holder's stay in school.

2. In the implementation of this project, the school authorities concerned are enjoined to negotiate only with duly authorized representatives of the Board of Transportation. Identity of these persons may be ascertained through presentation of official BOE ID or Letter of Authorization signed by the Chairman, Board of Transportation, with the seal of said office affixed thereto. This precaution is being made to preclude purchase of IDs from unauthorized sources.

3. Dissemination of the contents of this Department Memorandum to all concerned is desired.
