REGIONAL PRACTICAL ARTS WORKSHOP AND TEACHING INSTITUTES

1. In line with the upgrading of teacher's competencies in Practical Arts, the Educational Development Projects Implementing Task Force (EDPTAF) is hereby authorized to coordinate and monitor the conduct of the live-in Regional Practical Arts Teaching Institutes from April 23 to May 20, 1978, in the eleven trade schools and six agricultural schools/colleges listed hereunder:

2. This activity shall be a continuation and shall be in support of the materials development project being undertaken by the DEC. The primary objectives of the summer teaching institutes are as follows: a) to orient the practical arts teachers in the new direction of the program; b) to equip a number of practical arts teachers with skills and competence in carrying out the practical arts program; and c) to expose the teachers in the alternative approaches to the teaching of Practical Arts making the program implementable specially by the low resource schools.

3. The city/division superintendent shall nominate to the regional office at least two practical arts teachers. The final list of recommends will be forwarded to the regional training center one week before the training starts. One recommendee will be trained in the area of General Industrial and Business Distributive Arts; the other will be trained in the area of Agriculture, Fishery and Home Economics, depending on the school needs, and the qualifications and interest of the teacher actually teaching practical arts subjects.

4. For the purpose, the following suggested guidelines shall be considered in the nomination:

- a. that the secondary schools, private or public (national, provincial, city, municipal and barangay) shall be represented in these institutes;
- b. priority should be given to schools whose teachers in practical arts are not educationally qualified but were asked to teach such PA subjects; and
- c. willingness of the school head to help and support the teacher-participant to experiment with the innovations found to be suitable to both rural and urban setting as an activity in the implementation of the Revised Secondary Education Program particularly Practical Arts.

5. The CDC-USAT will handle the leadership of this program. The CDC's management and research staff, including that of CLSU-CDC, will assist in imparting to the participants the new concepts and new alternative approaches being developed.

6. Two Practical Arts area supervisors from each regional office, secondary school heads and two representatives from the Bureau of Secondary Education (BSE), Manila, shall participate in the seminar during the last 2 weeks of the institutes - 1 week in the area of industrial/business arts and 1 week in the area of agri-fishery and home economics.

7. Expenses for those teaching institutes as well as transportation (regular economy fare), board and lodging and training materials of the participants shall be borne by DPTTF, subject to its usual program management procedures and in accordance with auditing rules and regulations.

8. Immediate dissemination of this Memorandum is desired.
