1. Enclosed herewith is Proclamation No. 1711 of His Excellency, President Ferdinand E. Marcos, dated February 8, 1978, authorizing the Philippine Mental Health Association, Inc. (PMHA) to conduct a national membership, educational and fund campaign for the period January 1 to December 31, 1978.
2. The Philippine Mental Health Association, a non-profit and non-sectarian socio-civic organization has, since its foundation in 1950, made worthy contributions to the promotion of sound mental health.
3. The Proclamation specifically calls upon all citizens and residents of the Philippines to assist in this humanitarian endeavor by giving generously of their means.
4. School officials, teachers and other school employees, including pupils and students, are enjoined to assist and support wholeheartedly the campaign, particularly in the solicitation of contributions and donations.
5. Remittances shall be in check or money order drawn in favor of the Philippine Mental Health Association, Inc. and transmitted to the Department of Education and Culture, c/o Narciso Albaresin, Campaign Chairman, through the Regional Director. The transmittal letter should indicate in summary form the sources of the collection to enable the schools division committee to keep tab of the progress of the campaign and determine the extent of compliance of all concerned.
6. It is desired that the contents of this Memorandum be disseminated to all concerned.

PROCLAMATION NO. 171\*

AUTHORIZING THE PHILIPPINE MENTAL HEALTH ASSOCIATION, INC.  
TO CONDUCT A NATIONAL MEMBERSHIP, EDUCATIONAL AND  
FUND CAMPAIGN DURING THE PERIOD FROM JANUARY 1  
TO DECEMBER 31, 1978.

WHEREAS, the Philippine Mental Health Association, Inc. is a non-profit organization deeply involved in the preventive, curative and rehabilitative aspects of mental illness;

WHEREAS, said organization during its two decades of existence has demonstrated the value and importance of its services; and

WHEREAS, the Association needs more members in the movement and funds to broaden the scope of its preventive and rehabilitative projects;

NOW, THEREFORE, I FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by the law, do hereby authorize the Philippine Mental Health Association, Inc., to conduct a national membership, educational and fund campaign during the period from January 1 to December 31, 1978. I call upon all citizens and residents of the Philippines to assist in this humanitarian endeavor by giving generously of their means.

All donations and contributions to the Association shall be exempt from all taxes and the same shall constitute allowable deductions in full for income tax purposes of the donors.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.

Done in the City of Manila, this 6th day of February in the year of Our Lord, nineteen hundred and seventy-eight.
