TO : ALL HEADS OF DEPARTMENTS, BUREAUS, OFFICES  
AND AGENCIES OF THE FEDERAL AND LOCAL GOVERN-  
MENTS, INCLUDING GOVERNMENT-OWNED OR CONTROLLED  
CORPORATIONS.

SUBJECT : Amendment to CSC Memorandum Circular Nos. 3  
and 5, both series of 1974, require NISA  
clearance for original appointments and appoint-  
ments by way of reinstatement.

Civil Service Commission Memorandum Circular Nos. 3 and  
5, both series of 1974, require NISA clearance for original  
appointments and appointments by way of reinstatement.

This Commission believes that the above-mentioned require-  
ment should likewise be made to apply to other personnel actions,  
such as, appointments by transfer and promotional appointments,  
and contractual appointments covering a period of at least 6  
months, especially ... when the employee concerned has not under-  
gone any security check/investigation of any kind.

In view thereof, the above-mentioned Memorandum Circulars  
Nos. 3 and 5, both series of 1974, are hereby amended in the  
sense that NISA clearance is hereby required not only for ori-  
ginal appointments and appointments by way of reinstatement but  
also for other kinds of personnel actions, such as, appointments  
by transfer and promotional appointments, and contractual ap-  
pointments covering a period of at least 6 months.

Henceforth, any certification on the face of any appoint-  
ment made pursuant to Civil Service Commission Circular #10,  
series of 1975 is understood to include the requirement men-  
tioned herein.

THIS MEMORANDUM CIRCULAR SHALL TAKE EFFECT IMMEDIATELY.
