AUTHORIZING THE PHILIPPINE TUBERCULOSIS SOCIETY TO CONDUCT
THE 1978 NATIONAL EDUCATIONAL AND FUND CAMPAIGN

To: Bureau Directors
Regional Directors
Coordinator, State Colleges and Universities
School Superintendents
Heads of Private Schools, Colleges
and Universities

1. Enclosed is Proclamation No. 1712 of his Excellency, President Ferdinand E. Marcos dated February 8, 1978, authorizing the Philippine Tuberculosis Society, Inc. to conduct a National Educational and Fund Campaign from January 15 to December 31, 1978.
2. The Proclamation specifically calls upon all citizens and residents of the Philippines regardless of nationality and creed "to support actively and give generously of their time and resources to the Anti-TB cause, so as to hasten the control of this debilitating disease, minimize human suffering among the afflicted, and secure a healthier future free from its dangers for all our people".
3. Since the Proclamation allows solicitation of contributions for a worthy cause and in view of the improved and effective fight against tuberculosis through domiciliary visits especially in the rural and/or overcrowded areas, this Office strongly endorses this fund campaign. It is requested that all efforts be exerted to the end that school officials, teachers, faculty members, students, pupils and supporting school personnel of all schools, colleges and universities to give liberally to the society.
4. Remittances from each superintendent or school shall be in check or money order drawn in favor of the Philippine Tuberculosis Society, Inc. (1978 Fund Campaign) and transmitted to the Regional Office, e/o the Regional Director who, in turn, shall transmit said check and/or money order to the Department of Education and Culture, c/o Narciso Albaracin, Campaign Chairman. In every case, the transmittal letter

should indicate in summary form the sources of the collection to enable the Publications & Institutions Division of the Philippine Tuberculosis Society, Inc., to keep tab of the progress of the campaign and determine the extent of compliance of all concerned.

5. It is desired that this Memorandum be brought to the attention of all concerned for their information and guidance and that appropriate steps be taken immediately for its effective implementation.

PROCLAMATION NO. 1712

AUTHORIZING THE PHILIPPINE TUBERCULOSIS SOCIETY, INC. TO CONDUCT A NATIONAL EDUCATIONAL AND FUND CAMPAIGN DURING THE PERIOD FROM JANUARY 15 TO DECEMBER 31, 1978

WHEREAS, the Philippine Tuberculosis Society, Inc. complements and supports the program of the Government aimed at controlling and eventually eradicating tuberculosis as a cause of the physical, economic and social miseries of a great number of our people;

WHEREAS, there is an urgent need for the Philippine Tuberculosis Society, Inc. to continue with its activities of education, prevention and treatment in order to reduce the threat posed by this disease on the health of our people;

WHEREAS, the Philippine Tuberculosis Society, Inc. needs the intensified participation and involvement of all sectors of the community to support its expansion program aimed at accelerating its efforts to provide anti-TB services nationwide; and

WHEREAS, it is to the benefit of the community that the humanitarian objectives of the Philippine Tuberculosis Society, Inc. are successfully met;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines by virtue of the powers vested in me by law, do hereby authorize the Philippine Tuberculosis Society, Inc., to conduct its national educational and fund campaign during the period from January 15 to December 31, 1978,

I call upon all citizens and residents of the Philippines, regardless of race or creed, to support actively, and give generously of their time and resources to the anti-TB cause, so as to hasten the control of this debilitating disease, minimize human suffering among the afflicted, and secure a healthier future free from its dangers for all our people.

It is hereby reiterated that all donations and contributions to and income of the fund campaign shall be exempt from income, gift, amusement and all other taxes, and the same shall constitute allowable deductions in full from the income of the donors and contributors, and shall not be included for purpose of computing the maximum amount deductible under Section 30, paragraph (h), of the National Internal Revenue Code, as amended.

IN WITNESS WHEREOF, I have hereunto set my hand caused the seal of the Republic of the Philippines to be affixed.

Done in the City of Manila, this 8th day of February, in the year of Our Lord, nineteen hundred and seventy-eight.
