SUBMISSION OF REPORTS ON SOCIO-ECONOMIC PROJECTS

To: Bureau Directors  
Regional Directors  
Chiefs of Services and Heads of Units

1. As requested in Department Memorandum No. 176 s. 1975, quarterly reports on the implementation of socio-economic projects within each region or within the administrative jurisdiction of school officials concerned should be submitted to the Planning Service, DEC.
2. In this connection, the inclosed revised form is provided for gathering field data. Good pictures on the progress of implementation of socio-agro-industrial projects should accompany the reports, for record purposes.
3. As agreed upon at the meeting of assistant regional directors held at the PS Conference Room on March 11, 1977, the following schedule for the submission of quarterly reports for the calendar year will be observed:
  - a. Due 2nd week of last month of the quarter at the District Office/Institution.
  - b. Due 3rd week of last month of the quarter at the Division Office.
  - c. Due last week of last month of the quarter at the Regional Office.
  - d. Due second week of the beginning of the next quarter at the Planning Service, DEC.

4. Other existing projects under the administrative supervision of regional directors or other school officials, which are not indicated in the inclosure to Department Memorandum No. 176, s. 1975 should also be reported to the Planning Service, DEC.

5. The continued cooperation of all concerned is requested.
