Dear Secretary Manuel:

With reference to your Memorandum Circular No. 42, Series of 1978 dated February 7, 1978, I am happy to inform you that we have finalized arrangements with the Philippine National Bank in Escolta, Manila for them to be the exclusive depository of all payments of student cards. Under the arrangement all payments shall be made payable, if in checks directly to the "Student ID Fund", PNB, Manila. In the provinces, payments should be by telegraphic transfer also to the "Student ID Fund", PNB, Manila. In no instance should checks be made payable to any person. Hereunder is a pertinent portion of the letter of President Danilo O. Domingo of the PNB, as follows:

"(1) that schools will remit only once in the sense that this remittance or deposit will cover full payment of the IDs of all their students.

(2) In the case of public schools, it would be simpler if the remittance is made by the division superintendent of the district which will cover collections from all the public schools under his supervision."

The cost of telegraphic transfers have been fixed by the PNB at 1/32 of 1%, minimum of P1.00, plus the cost of the telegram. These expenses may be deducted from the remittances but a letter to this effect will be appreciated by this Board.

It will be appreciated if a supplementary memorandum circular be issued by you covering the foregoing arrangements with the PNB.
