FOURTH NATIONAL CONGRESS OF COLLEGE STUDENTS

To: Bureau Directors
Regional Directors
Coordinator, State Colleges and Universities
School Superintendents
Heads of Private Schools, Colleges and Universities

1. In line with the Government's emphasis on youth involvement in nation-building, the Fourth National Congress of College Students will be held on December 19-23, 1978, in the Senior Mess of Deschore Camp, Baguio City, and on December 30, 1978, at Rizal Park, Manila, under the auspices of the YMCA of Manila in collaboration with the Ministry of Education and Culture.
2. The theme of the Congress is "Ang Kabataang Kabaliket sa Kaunlaran," with the following as sub-topics:
 - a. Youth and Rural Development
 - b. Manpower Development
 - c. Youth and Social Progress
3. The Congress intends to attain the following objectives:
 - a. To understand the socio-economic basis of development in nation-building.
 - b. To appreciate the role of development in nation-building.
 - c. To provide opportunities for actual participation in national development activities.

4. The Congress is open to college students taking degree courses, preferably those with experience in youth leadership training projects/activities. Student-delegates shall be at least a second year college student and must be recommended by a school, college or university head.

5. All schools, colleges, and universities are urged to participate in the Congress. Heads of schools, colleges and universities are authorized to recommend not more than ten (10) selected students from each institution to attend the Congress. Deadline for the submission of applications of student-delegates is November 30, 1978. Included is a copy of the application form.

6. Conference fees and expenses for accommodations, transportation, and other items that may be incurred in connection with attendance in the Congress shall be borne by the school, college or university represented or by any private organization.

7. A certificate of attendance signed by the Deputy Minister of Education and Culture and the President of the YMCA of Manila will be given to each participant. Time spent for actual civic action work while attending the conference shall be credited as partial fulfillment of USAF requirements, subject to the provisions of Department Order No. 18, s. 1977, entitled "Guidelines on the Implementation of the Youth Civic Action Program."

8. Student-delegates shall submit reports on their participation in the conference which shall include a summary of the discussions taken up, prescribed materials and handouts, as well as their recommendations.
