TEACHER TRAINING PROGRAM IN SPECIAL EDUCATION 1979-1980

To Bureau Director,  
Regional Directors  
Chiefs of Services and Heads of Units

1 The Scholarship Committee of the Ministry of Education and Culture hereby announces the training program in Special Education for the school year 1979-1980 at the Philippine Normal College and the University of the Philippines

2 Funds for this program will be charged against the appropriations provided for in R.A. No. 3562 entitled "An Act to Promote the Education of the Blind in the Philippines" and R.A. No. 5250, "An Act Establishing a Ten-Year Training Program for Teachers of Special and Exceptional Children in the Philippines and Authorizing the Appropriation of Funds Therefor"

3 The training program for the teachers shall run for a period of one summer and two semesters starting in summer of 1979, and shall lead to a certificate of proficiency in any of the following areas

- a Education of the Gifted/Fast Learners
- b Education of the Mentally Retarded/Slow Learners
- c Education of the Visually Impaired
- d Education of the Hearing Impaired
- e Education of Children with Behavior Problems/  
Emotionally Disturbed

4 Each division may nominate as many as there are qualified candidates for each area of specialization. The screening committee of the regional office will in turn select three (3) candidates for each area of specialization from each division. Researchers of the Special Education Division, Bureau of Elementary Education, will interview and administer tests to candidates recommended by the regional screening committee according to the schedule below

5. Candidates for the teaching position must meet the following requirements:

- a. Educational qualification - Bachelor's Degree, or its equivalent
- b. Civil service eligibility - Factor 1
- c. Performance rating - Very satisfactory for the last three (3) years
- d. Scholastic ability - Not lower than B or 2 or its equivalent to be able to qualify for admission to the graduate school either at the Philippine Normal College or at the University of the Philippines
- e. Experience - Teacher must actually be in the public schools, on permanent status and has had at least three (3) years of successful teaching experience with normal children
- f. Health - Must be emotionally stable and physically fit as indicated in a health examination conducted and certified to by a government physician to conduct division-wide surveys and carry out a screening program in addition to actual teaching of deviant children
- g. Special qualification - Must have genuine interest in and dedication to the education of exceptional children with qualities of leadership and personality traits for sequence specialization
- h. Age - The teacher nominee should not be more than 40 years old
- i. Status and sex - Single teachers are preferred, male recommendees needed for teachers of the blind
- j. The nominee must not have any pending administrative case as indicated in a certification by the head of the agency or institution.







k The nominee should not have been a recipient of any scholarship or bursary of similar nature for the last five (5) years immediately preceding the nomination.

6 Each nominee will be entitled to the following privileges:

- a Study leave with pay for the duration of the training
- b Free tuition for other or master's degree
- c Book allowance of \$800 for the whole year
- d Monthly stipend of \$400 and per diem of transportation including the summer travel and
- e Transportation expenses to Manila and return to be charged against local funds

7 Obligations of the grantee - When the nominee is finally selected for the training program, he/she shall, in consideration of his/her acceptance, bind himself/herself to the following conditions:

- a Keep up with the standards, terms and conditions of the scholarship
- b Serve for a period of two years after the termination of his/her scholarship or a fraction thereof
- c Refund to the government such amounts as may have been defrayed for his/her transportation, salary, stipend, allowances, and other expenses incident to his scholarship grant for:

- (1) Failure to render, in full or in part the required length of service referred to above on account of resignation, voluntary retirement, separation from the service through his/her own fault, or other causes within his control, and
- (2) For his/her recall or cancellation of his/her scholarship grant due to his/her own fault or willful neglect

- d Grantees must be prepared to advance expenses for stipend, and book allowance on their own funds and not released on time.

8 Each nominee should submit to the NEC screening committee during the interview, three (3) copies of each of the following documents, unless otherwise specified:

- a Information sheet (Enclosure No. 1) duly accomplished and certified to by the head of his/her agency/office or institution
