PLANNING CONFERENCE ON THE REGIONAL
HEALTH GUARDIAN SCHOOL MODEL

To: Bureau Directors
Regional Directors
Coordinator, State Colleges and Universities
Schools Superintendents
Heads of Private Schools,
Colleges and Universities

1. A three-day planning conference on the Regional Health Guardian School Model will be held on November 20-22, 1978, at the Applied Nutrition Center in Banilad, Cebu City. The conference aims to:

- a. orient the participants on the rationale, philosophy and objectives of the School Health Guardian Program;
- b. prepare the Program of Work for the Regional Health Guardian School Model;
- c. discuss ways and means of integrating the School Health Guardian concept in the curriculum.

It covers the following aspects: "Alay tanin" and model school orchard, school feeding, health education, nutrition education, environmental sanitation, responsible parenthood and health services particularly the identification of common ailments and their treatment with the use of indigenous plants and herbs.

2. The regional directors are requested to bring six copies of the proto-type integrated units for the grades assigned to them, prepared in the region, to be used as working papers.

3. The participants of the conference are:
 - a. The regional director or its representative
 - b. The chief of the Elementary Division of the region
 - c. The superintendent (or his representative) of the division where the Regional Health Guardian School Model is located
 - d. The coordinator of the School Health Guardian Program of the division where the Regional Health Guardian School Model is located
 - e. The district supervisor of the district where the School Model is located
 - f. The principal of the School Model

The Office of the Minister of Education and Culture will be represented by the Directors of the Staff Bureaus, the Chief of the Educational Planning Service, the Officer-in-Charge of the National Research Development Center for Teacher Education and the Director and Staff of the School Health and Nutrition Center.

4. The travel expenses of the participants shall be charged against the funds of the School Health and Nutrition Center.

5. The Regional Director of Region VII is requested to take charge of the arrangement of meals, lodging of the participants and physical facilities needed for the conference.

6. It is desired that this matter be brought immediately to the attention of those concerned for proper action.
