ANNUAL CONVENTION OF THE PHILIPPINE SOCIETY  
OF DIETITIANS AND NUTRITIONISTS, INC.

1. Conformably to Memorandum Circular No. 1098 dated November 14, 1978, copy on the reverse side, the Philippine Society of Dietitians and Nutritionists, Inc. (PSDN) will hold its Annual Convention on December 14-15, 1978, at the Philippine Heart Center for Asia, Quezon City, on the theme "Nutrition Planning." The convention aims to discuss systematic planning for the administration of government programs in nutrition.
2. The Office of the President has authorized the participation, or official time, of not more than three (3) dietitians/nutritionists and other professionals from each bureaus and offices and other instrumentalities of the government involved in nutrition. Expenses incurred by the delegates and a registration fee of P50 per participant shall be charged against local funds, subject to the usual accounting and auditing rules and regulations. Participants stationed within Metro Manila area shall be entitled to convention fee only.
3. It is requested that this Memorandum be given the widest publicity.

MEMORANDUM CIRCULAR NO. 1096

AUTHORIZING ATTENDANCE IN THE ANNUAL CONVENTION OF THE PHILIPPINE  
SOCIETY OF DIETITIANS AND NUTRITIONISTS, INC.

The Philippine Society of Dietitians and Nutritionists, Inc. will hold its annual convention at the Philippine Heart Center for Asia on December 14-16, 1978, on the theme: "NUTRITION PLANNING."

The convention aims to discuss systematic planning for the administration of government programs in nutrition.

Heads of departments, bureaus and offices, and other instrumentalities of the government involved in nutrition, are hereby authorized to send not more than three (3) dietitians and/or nutritionists each, preferably members of the society, to the convention on official time with reasonable expenses for transportation, per diem and a convention fee of not exceeding P50.00 per participant, chargeable against the appropriations of their respective offices, in accordance with the provisions of Presidential Decree No. 342 dated November 26, 1973, as implemented by GCA General Circular No. 127, series of 1973, subject to the availability of funds and the usual accounting and auditing requirements, as an exception to Memorandum Circular No. 593 of this Office dated August 8, 1972. Participants residing or stationed within the Metro Manila Area shall be entitled to convention fees only. Meals included in the convention fee shall be deducted from per diem.

Each participant shall submit to his agency head a complete report on his attendance or participation in the convention as prescribed under Memorandum Circular No. 287 dated June 10, 1977. Likewise, the organizer shall submit to this Office a report and evaluation of the convention, copy furnished the Ministry of the Budget, including a list of participants from the government sector indicating their respective offices.
