

Dear Miniater Manuel:

Presidential Decree No. 1508 establishing a System of Amicaoly Settling Disputes at the Barangay Level, signed by the President last June 11, 1978 will be discussed in a seminar-workshop in three separate regions. In the implementation of this Decree, the assistance of your office is urgently necessary. In view thereof, therefore, may we respectfully request that you authorize the participation of Division Superintendent of Schools to participate in the regional seminar on the subject, scheduled in the following places:

However, in view of the very limited funds which the Ministry of the Budget released for the initial implementation of PD 1508, as agreed in provious meeting of the members of the Katarungang Pambarangay Commission at the Manila Hotel last November 1978, the member ministries of the Katarungang Pambarangay Commission will shoulder the transportation expenses and per diems of their respective participants from their respective stations to the regional sites of the conference including authorized per diems. However, training materials, kits including lunch and snacks during the 2-day seminar workshop will be taken cared of by the Ministry of Local Government and Community Development which is charged in the implementation of PD 1508 as provided in Section 16 of said Decree.

These regional conferences are nacessary in the effective implementation of this decree. The other participants who will attend these seminars are the Provincial Commanders, provincial/City Fiscals and Provincial Development Officers of the MIGCD. Just like the Ministry of Education and Culture, participants coming from these ministries will shoulder their transportation expenses and per diems for the Curation.
