1979 SUMMER INSTITUTE ON YOUTH VOLUMPERS
MANAGEMENT FOR YOAP COORDINATORS

- 1. The Ministry of Education and Culture (MEC) through the National YCAF Coordinating Contar and Dangerous Drugs Hoard (DDB) are jointly sponsoring a three-week Summer Institute on Youth Volunteer Management for YCAF coordinators at Baguio Vacation Normal School, Teachers Camp, Haguio City from May 7 to 27, 1979. The training courses, Phase I and Phase II, shall be conducted simultaneously on these dates.
- 2. The courses offered are based on the approved curriculum for Master of Arts in Education on Youth Voluntoor Management with the corresponding number of units to be credited by the Baguio Vacation Normal School as indicated in Inclosure No. 2 of MEC Memograndum No. 293, s. 1978.
- 3. The objectives of the summer institute are as follows:

Phase I

- a. Re-orient YCAP coordinators on the objectives and revitalized Youth Civic Astion Program in the total national development effort of the New Society;
- b. Acquaint participants with their roles, functions and responsibilities in the effective implementation of the Youth Countryside Action for Progress;

- c. Develop regional, division and school YCAP action plans geared to the development of rural and depr seed communities for the echool year 1979-1980; and
- d. Orient participants in the newer strategies and approaches in YCAP program including Mobile School Theatre and YCAP Mobile Cinema.

Phase II

- a. Analyze the impact of YCAP as implemented in the districts, divisions and regions;
- Evaluate the driving and restraining forces in the successful implementation of YCAP;
- c. Re-orient participants on atrategies of the seven program thrusts of YCAP; and
- d. Prepare a 5-year YCAP development plan for their respective school/division/region.
- 4. Farticipants to this 1979 Summer Institute shall be as follows:

Phase I

One outstanding YCAP coordinator and full-time regional YCAP coordinator from each region duly certified by the regional director.

One only designated full time division YCAP coordinator, with an outstanding performance/contribution to the YCAP for the school year 1975-1979. In the absence of the division YCAP coordinator, an outstanding district YCAP coordinator duly certified by the schools division superintendent may be designated.

Phase II

One (1) participant from each region and school division who has successfully completed the first phase of the Summer Leadership Institute on Youth Volunteer Management in Baguic City. He/she must be designated YCAP coordinator and have actually performed as such during the school year 1976-1979.

- Expenses for twition fees, and board and lodging of each perticipant, shall be taken from the DAP-YCAP project funding of the Dangerous Drugs Board. Transportation to and from Baguio City and other insidental expenses incurred by each participant shall be charged against local funds, subject to the usual accounting and auditing regulations.
- 6. The names of participants duly certified by their respective schools superintendents and/or regional directors should be submitted to the National YCAP Coordinating Center on or before March 17, 1979. All participants shall fill-up and submit the inclosed form upon registration.
- Administrators of private schools and interested vocational institutions and presidents of state colleges and universities may send the names of their recommendees to this institute on or before March 15, 1979, subject to final screening by the Mational YCAP Coordinating Center. Only duly design nated or appointed YCAP ocordinators may be nominated. All expenses including tuition, board and lodging fees, transportation and per diess shall be borne by their respective echools or division depending upon the availability of funds subject to the usual accounting and auditing regulations.
- ·B. It is desired that this Memorandum be disseminated to the field as soon as possible.

To reimburge to the Republic of the Philippines, through the Ministry of Education and Culture, the mount equal to the total compensation paid to me during the period of my scholarship in the event that, through inexcusable neglect or circumstances within my control, I fail to abide by the terms of this contract at any time during or after the period of my scholarship.
