MEMBERSHIP AND FUND DRIVE

1. The 32nd Annual Membership and Fund Campaign of the Philippine National Red Cross will be conducted from January 15 to August 31, 1979. Presidential Decree No. 1267 states that membership in the PNRC shall be open to the entire population of the Philippines regardless of citizenship, and the contributions shall be deductible in full for taxation purposes.
2. In view of the laudable reasons for which this organization exists and the need to involve every resident of our country in this humanitarian undertaking, this Office strongly endorses this membership and fund drive. All officials and employees of the Ministry of Education and Culture, including school officials and teachers in the field, as well as school children and students are enjoined to give their full support and wholehearted cooperation in the membership and fund campaign.
3. Immediate dissemination of this Memorandum is requested.


Subject : 1979 (32nd) Annual Membership and Fund Campaign

Section 11, Presidential Decree 1264 amending RA 95 which specifically covers the Annual Membership and Fund Campaign of the Philippine National Red Cross provides:

"SECTION 11. As a national voluntary organization, the Philippine National Red Cross shall be financed primarily by contributions obtained through solicitation campaigns throughout the year which shall be organized by the Board of Governors and conducted by the Chapters in their respective jurisdictions. These fund raising campaigns shall be conducted independently of other fund drives by other organizations."

In view thereof, it is hereby announced and the field is enjoined to conduct the 32ND ANNUAL MEMBERSHIP AND FUND CAMPAIGN from January 15th to August 31st, as has been done in the past. It is expected that the main thrust of the Fund Campaign will be concentrated within the said period of January 15th to August 31st, at the end of which, fund campaign goals would have been subscribed or oversubscribed.
