1979 ALAY TANIM CONTEST

To: Bureau Directors
Regional Directors
Schools Superintendents

1. The fourth National Alay Tanim Contest will be conducted from June 4, 1979 to March 31, 1980.
2. The contest this school year highlights Phase IV of the implementation of LOI 586 or Alay Tanim Program which has been expanded to include the closely related School Health Guardian Program (SHGP) embodied in LOI 764. Phase IV seeks to strengthen further the implementation of all the aspects of the School Health Guardian Program, namely, (a) division/regional model orchards and Alay Tanim, (b) nutrition education (c) medicinal plants, (d) health services, and (e) environmental sanitation, in all the divisions of the 13 regions.
3. In this connection, a separate prize will be awarded to each regional winner for the highest pointer in the implementation of LOI 764. It is requested therefore that each region select one (1) division entry for the best implementor of the Alay Tanim Program (LOI 586) and of the School Health Guardian Program (LOI 764), to be submitted to the National Evaluation Committee, MEC, Manila, Attention: Assistant Secretary Vedasto G. Suarez.
4. Division/Regional evaluation of entries should be a continuing and progressive process. Said evaluation should be an integral part of the regular supervision program of the division/region and not a one-shot deal.
5. The national evaluation teams will start evaluating regional division entries on October 1, 1979. The names of the members of the teams are found in Inclosure No. 2 to this Memorandum. The regional and national winners will be announced in December 1979.



6. The guidelines for the implementation of LOIs Nos. 586 and 764 which may be used as basis for the selection of the regional winners for the SHGP and the national winners for Alay Tanim are found in Inclosure No. 1 to this Memorandum for ready reference.

7. The basis for the selection of National Alay Tanim winners will be the proper implementation of the guidelines in Numbers I and II.

8. In accordance with LOI 586, one (1) school building including construction cost will be awarded to each of the winners on the regional level as well as to the winner/winners on the national level. Special awards will be given to regions or divisions for having won on the national level for three (3) successive years. A certificate of appreciation or merit will also be given to individual schools, districts or divisions with outstanding accomplishments.

9. Also, it may be mentioned here that Paragraph 5 of LOI 764 states that the annual school building program shall provide for at least one (1) school health guardian building per region, as determined by the Minister of Education and Culture.

10. Immediate dissemination of the contents of this Memorandum and the inclosures is desired.

I. IMPLEMENTING GUIDELINES FOR THE SELECTION OF REGIONAL ALAY TANIM WINNERS (LOI 586)

1. Division/Regional model orchards and Alay Tanim projects . . . 45 points
 - a. Number of fruit, forest and ornamental trees planted and living during the year.
 - b. Model orchard management and maintenance
 - c. Degree of implementation of the division orchard development plan
 - d. Number of orchard projects within the division
 - e. Submission of 1979 consolidated regional Alay Tanim report
2. NUTRITION 20 points
 - a. Supplementary feeding - utilization of indigenous foods
 - b. Selective food production - planting of priority crops
3. Water and soil conservation 10 points
4. School campus beautification and landscaping 10 points
5. Community involvement on Alay Tanim projects 15 points

II. IMPLEMENTING GUIDELINES FOR THE SELECTION OF HEALTH GUARDIAN PILOT SCHOOLS (LOI 764)

1. Medicinal Plants 30 points
 - a. Number and variety of medicinal plants being cultured within the division
 - b. Studies/researches on medicinal plants including such items as to uses, parts used, preparation, dosage, etc.
 - c. Consolidated reports/album/scrapbook (refer to MEC Memo. No. 16, p. 1)
 - d. Actual use of medicinal plants in treating common ailments in the school and community
2. Health Services 20 points
 - a. Presence of functional clinic - adequate facilities and medicines for common ailments
 - b. Presence of properly managed canteen/cafeteria and other feeding activities - non-profit or service-oriented, utilizes and serves indigenous foods produced from the school and home garden
 - c. Accurate record keeping of height and weight, of treatment, etc.
 - d. Evidence of guidance/physical examinations/treatments among pupils
3. Integration of health and nutrition education in curricular offerings 15 points
4. Environmental sanitation 10 points
 - a. Proper waste and garbage disposal
 - b. Recycling of waste materials
 - c. Drainage and sewerage system
5. Alay Tanim, orchards project, and other food production activities 10 points
6. Community involvement in school health guardian programs . . . 15 points
