AUTHORIZING THE PHILIPPINE TUBERCULOSIS SOCIETY TO CONDUCT
THE 1979 NATIONAL EDUCATIONAL AND FUND CAMPAIGN

To: Bureau Directors
Regional Directors
Presidents, State Colleges and Universities
Schools Superintendents
Heads of Private Schools, Colleges
and Universities

1. Inclosed is Proclamation No. 1848 of His Excellency, President Ferdinand E. Marcos, dated April 26, 1979, authorizing the Philippine Tuberculosis Society, Inc. to conduct a national educational and fund campaign from January 15 to December 31, 1979.
2. The Proclamation specifically calls upon all citizens and residents of the Philippines regardless of race and creed "to support actively and give generously of their time and resources to the Anti-TB cause, so as to hasten the control of this debilitating disease, minimize human suffering among the afflicted, and promote national strength and prosperity through a healthy citizenry free from the dangers of the disease."
3. Since the Proclamation allows solicitation of contributions for a worthy cause and in view of the improved and effective fight against tuberculosis through domiciliary visits especially in the rural and/or overcrowded areas, this Office strongly endorses this fund campaign. It is requested that all efforts be exerted to the end that school officials, teachers, faculty members, students, pupils, and other school personnel give liberally to the Society.
4. Remittances from each superintendent or school shall be in check or money order drawn in favor of the Philippine Tuberculosis Society, Inc. (1979 Fund Campaign) and transmitted to the Regional Office, c/o the Regional Director who, in turn, shall transmit said check and/or money order to the Ministry of Education and Culture, c/o Deputy Minister Narciso Albarracin, Campaign Chairman. In every case, the transmittal letter should indicate in summary form the sources of the collection to enable the Educational Institutions Division of the Philippine Tuberculosis Society, Inc. to keep tab of the progress of the campaign and determine the extent of compliance of all concerned.

5. To avoid overlapping in the campaign effort of all participating agencies, it should be understood that donations to the 1979 Anti-TB Fund Campaign raised from Educational Institutions Division shall not be claimed by any of the fund campaign unit as part of the over-all collection of a province or city notwithstanding the fact that a school superintendent or a school head may be a member of any of the provincial or city fund campaign committees.

6. It is desired that this Memorandum be brought to the attention of all concerned for their information and guidance and that appropriate steps be taken immediately for its effective implementation.

PROCLAMATION NO. 1648

AUTHORIZING THE PHILIPPINE TUBERCULOSIS SOCIETY, INC. TO CONDUCT
A NATIONAL EDUCATIONAL AND FUND CAMPAIGN DURING THE PERIOD
FROM JANUARY 15 TO DECEMBER 31, 1979

WHEREAS, the Philippine Tuberculosis Society, Inc., conducts a campaign to control and eventually eliminate tuberculosis as a major cause of the physical, economic and social miseries of our people and thereby complements and supports the National TB Control Program of the Government;

WHEREAS, the Philippine Tuberculosis Society, Inc. must continue its educational, prevention and treatment activities so as to reduce the threat posed by TB on the health and welfare of our people;

WHEREAS, the Philippine Tuberculosis Society, Inc. must continue to accelerate its expansion program to bring the benefits of its domiciliary and dispensary services to a bigger number of people;

WHEREAS, the Philippine Tuberculosis Society, Inc. campaign needs intensified community support, participation and involvement to achieve its objectives; and

WHEREAS, it is to the benefit of the community that the humanitarian objectives of the Philippine Tuberculosis Society, Inc. campaign are met;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by law, do hereby authorize the Philippine Tuberculosis Society, Inc. to conduct a national educational and fund campaign during the period from January 15 to December 31, 1979.

I call upon all citizens and residents of the Philippines, regardless of race or creed, to support actively, and give generously of their time and resources to the anti-TB cause, so as to hasten the control of this debilitating disease, minimize human suffering among the afflicted, and promote national strength and prosperity through a healthy citizenry free from the dangers of the disease.

Furthermore, I call upon and authorize all government financing institutions and government corporations to fully support this fund drive by contributing generously from their funds. This is an exemption from the provisions of LOI 626, No. 2(c).



It is hereby reiterated that all donations and contributions to the fund campaign shall be exempt from income, gift, amusement and all other taxes, and the same shall constitute allowable deductions in full from the income of the donors and contributors, and shall not be included for purposes of computing the maximum amount deductible under Section 30, paragraph (h), of the National Internal Revenue Code, as amended.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.

Done in the City of Manila, this 26th day of April in the year of Our Lord, nineteen hundred and seventy-nine.
