GUIDELINES ON THE 1979-1981 MEC-PHILAMLIFE SCHOLARSHIP
PROGRAM IN GUIDANCE (GRADUATE LEVEL)

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges and Universities

1 The 1979-1981 MEC-Philamlife Scholarship Program in Guidance will start during the second semester of school year 1979-1980.

2 Accordingly, the following dates have been set for the various activities relative to the selection of the scholars

- a. June 30, 1979 - Receipt of application forms and information sheets by the MEC regional offices from the Philippine American Life Insurance Company, Manila
- b. July 16, 1979 - Last day for the submission of names of candidates nominated by the division schools superintendents to their respective regional directors
- c. August 6, 1979 - Deadline for the submission by the regional directors of the nomination papers and supporting documents of five (5) nominees from each region to

- d August 15-31, 1979 - Testing and interview of nominees by MEC-UP teams
- e. September 24, 1979 - Final selection of scholars by the MEC-Philamlife-UP Scholarship Committee
- f October 8-22, 1979 - Announcement of scholars, orientation, and pre-enrollment activities
- g October 29, 1979 - Registration in the university by the scholars

3 Attention is called to the fact that these scholarship grants are available to qualified high school teachers/guidance counselors with permanent appointment in both public and private schools. It is stipulated that the MEC or the private schools, as the case may be, will continue to pay the salaries of their scholars for the duration of the scholarship grant covering three semesters and one summer (or seventeen months). In view of this, therefore, private schools that are not in a position to comply with this stipulation need not submit nominees for the scholarship.

4 Private schools whose teacher/guidance counselor-nominees are finally chosen as scholars will be required to sign an agreement with the Philippine American Life Insurance Company to the effect that they are willing to pay their scholars their full salary while on study leave.

5 Attention is invited to paragraph 4 of Department Memorandum No. 138, s. 1978, pertinent to qualifications of candidates and to that portion on supporting documents to accompany each nomination.

6 Immediate dissemination of this Memorandum is earnestly requested.
