THE CMLI NATIONAL HONOR SOCIETY OF SECONDARY SCHOOL STUDENTS

To: Bureau Directors
Regional Directors
Presidents, State Colleges and Universities
Schools Superintendents
Heads of Private Schools, Colleges and Universities

1. In line with the earnest desire of the Children's Museum and Library, Inc., to develop leadership, character, citizenship and academic excellence through outstanding services to school and community, the CMLI National Honor Society of Secondary School Students is being reorganized so that deserving students shall be given due recognition.

2. The following guidelines should be used in the selection of nominees to this honor society for secondary school students:

- a. Nominees should be students from any private or public high school whose names appear on record as having been recipients of an award as model students as defined by the CMLI Citizenship Training and Character Building Committee;
- b. The nominees must belong to the first five ranking students of their curriculum year;
- c. A certification from the school principal that the nominees possess the qualifications mentioned in 1 and 2 must accompany the nomination;
- d. The nominees must have had some outstanding achievements in community service, civic projects, literary-writing, debates, science and similar activities or have done acts of heroism and valor. Their outstanding achievement must be supported by documentary evidences such as awards, certificates, medals, etc.
- e. The nominees' application forms must be signed by the principal of the school and approved and duly signed by the local screening committee or director;

i. Any application without the necessary supporting papers shall not be considered.

3. Nomination for membership should be submitted at the close of the school year, but not later than the opening of the following school year. In this connection, it is requested that each Director emphasize the prompt submission of the nominees' papers. The nominees' papers should be submitted direct to the President of the GLEI, Queen City, furnishing this Office a copy of the names of the nominees and their respective schools.

4. Inclosed are the information materials including the pledge regarding the GLEI National Honor Society of Secondary School Students.

MEMBERSHIP OF THE CMLI NATIONAL HONOR SOCIETY FOR SECONDARY STUDENTS

The second, third and fourth year students from private and public high schools whose names appear on record as having been recipients of an award as model students as defined by the CMLI Citizenship Training and Character Building Committee constitute the group from which prospective members will be chosen. This means that as a model student a prospective candidate has undergone previous selection on the basis of the following:

Character	20%
Scholastic Standing	10%
Participation in School and Community Programs and Extra Curricular Activities	20%
Exhibition of Special Talent	10%
Health	10%

8a - Character and Conduct

This is the sum total of the character traits, habits and conduct of the candidate which would serve as an index to his nature as a person. The standing on character and conduct shall be based on the combined judgment of all subject teachers of the candidate.

8b - Scholastic Standing

This constitutes the final general average of the candidate in his academic, vocational, and IPE/CAT subjects as which the grade is determined as integrated.

8c - Participation in School and Community Programs and Activities

This refers to the number of activities in which the candidate participated as well as to the quality of his performance.

8d - Creativity and Special Talent

This refers to the quality and purposes and extent to which his gifts of creativity and talent are utilized.

8e - Health

This gives, as much as possible, equal weight to physical and mental health.

Among the candidates, one may be recommended by the Regional Committee to be a member of the Philippine National CMLI Honor Society of Secondary School Students if:

1. He has made some outstanding achievement in any field

civic projects, acts of heroism and valor, etc. which is supported by documentary evidence like an award or certificate.

2. He is a high school student who belongs to the first five of the total number of his curriculum level, the ratings to be based on the last grading period.



IV. HONOR SOCIETY

A student who has a good standing in his maintenance of the standards of good character, spirit, achievement and conduct.

Such a student, when called, is automatically become an honor member.

V. HONOR SOCIETY

A student who is not being to the first five of the member of the honor society in the following school year is disqualified until he regains his academic status.

A student who is reported and found guilty of gross misconduct.

VI. NATIONAL HONOR SOCIETY OF SECONDARY SCHOOL STUDENTS WILL

The National Honor Society of Secondary School Student shall be a body of a group of students composed of fifteen members including the president, the secretary, treasurer, editor, public relations and other related officers.

VII. NATIONAL HONOR SOCIETY OF SECONDARY SCHOOL

The National Honor Society, Incorporated Citizenship Training Program, in association with the Ministry of Education.
