LATERAL COORDINATION WITH OTHER GOVERNMENT AGENCIES IN THE  
LOCALITY IN CONNECTION WITH THE ADMINISTRATION  
OF THE 1979 NCEE

To: Regional Directors  
Schools Superintendents  
Presidents, State Colleges and Universities  
Heads of Private Schools, Colleges and Universities

1. The success of the administration of the National College Entrance Examination (NCEE) simultaneously throughout the country on November 11, 1979, will largely depend upon the concerted cooperation of all concerned in the implementation of the program. Regional directors and schools division superintendents are tasked to provide the needed leadership to insure the success of the NCEE project, code named "SIGLA."
2. A meeting with the representatives of the different agencies mentioned in the inclosed Presidential Memorandum Circular No. 1163 dated August 30, 1979, was held at the National Educational Testing Center (NETC), Manila, regarding the problems of transportation facilities in the different regions of the country. The conferees pledged full support to the project.
3. The sectoral representatives request that each MEC regional director and/or schools division superintendent concerned should present their problems regarding transportation facilities to the directors or officers in charge of the supporting agencies. They should likewise identify specific areas or places where their services are needed.
4. A report on the coordination made should be submitted to NETC, Arzonos, St., Manila, not later than October 15, 1979 so that appropriate action can be taken for its implementation.
5. Compliance with this Memorandum is desired.

MEMORANDUM FOR THE PRESIDENT

URGENT REQUESTS FOR ASSISTANCE CONCERNING THE NATIONAL SUPPORT AND ASSISTANCE TO THE NATIONAL BOARD EXAMINATION CENTER, MINISTRY OF EDUCATION AND CULTURE (MTC), IN CONNECTION WITH THE CONDUCT OF THE NATIONAL BOARD EXAMINATION (NBE)

WHEREAS, the National Educational Testing Center (NETC), Ministry of Education and Culture (MTC), is charged with the duty of administering the National Board Examination (NBE) required of all high school graduates seeking admission to post-secondary course programs to pass said examination, as provided under Presidential Decree No. 143 dated March 9, 1973;

WHEREAS, the NBE is scheduled to be given on November 11, 1973 to about 1,300 examination centers throughout the country to more than half-a-million examinees, a job of great magnitude under the prevailing conditions of the Philippines;

WHEREAS, the Ministry of National Defense (MND), the Armed Forces of the Philippines (AFP), the National Intelligence and Security Authority (NISA), the Integrated National Police (INP), and the Philippine Ports Authority (PPA), are hereby tasked to extend maximum support and assistance to the NETC, MTC, to ensure full security and smooth administration of the 1973 NBE all over the country.

In a similar vein, the Ministry of Local Government and Community Development (MLGD), the Philippine National Police (PNP), the Philippine Airlines (PAL), the Ministry of Public Works (MPW), the Ministry of Public Works (MPW), the National Road and Transport Office (NRO), and the National Grains Authority (NSA) are hereby requested to extend their full assistance as may be deemed necessary for the smooth administration of the aforementioned examination.

The Ministry of Health (MOH), the National Media Production Center (NMPC), and the Bureau of Communications (BUREL), are likewise enjoined to extend maximum support and assistance relative to the dissemination of essential information pertaining to the conduct of the examination and the utilization of communication facilities throughout the country, respectively;
