RECruitment OF BVNS FACULTY STAFF

To: Bureau Directors
Regional Directors
Chiefs of Services and Heads of Units
Presidents, State Colleges and

1. The 1980 Baguio Vacation Normal School (BVNS) will offer graduate, undergraduate and leadership/seminar courses for teachers and other school officials at all levels at Teachers Camp, Baguio City.

2. As part of the MEC Staff Development Program, the BVNS is envisioned as a cooperative enterprise among the different MEC agencies. In this connection, the regional and bureau directors, and other officials of this Ministry are enjoined to participate in the recruitment of faculty members for this particular summer term which starts on April 1st and ends on May 24, 1980.

3. The following fields of specialization where the services of Faculty staff will be needed are: Social Studies, Science, Mathematics, Communication Arts (English or Filipino), Educational Administration and Supervision, Adult Education, Functional Literacy, Guidance and Counseling, Educational Media, Pre-Elementary Education, School Health Education, Home Economics, Music and Physical Education. Recommendations may be made from among applicants who have efficiently served at the BVNS as well as those who have not, but meet the qualifications called for in the succeeding paragraph.

4. The recommendee should have at least a master's degree, and preferably should hold doctoral degree in his field of specialization. He should have taught in his major field for at least 5 years,

and should have high leadership potential, sound mental health and good physical condition. Only in cases where a high degree of expertise and when no other recommendee is qualified may any of those requirements be waived. No application will be processed unless it is accompanied by official transcripts of records.

5. Applications should be properly indorsed by the City or Provincial Schools Superintendents or Heads of Office or Agency concerned and approved by their respective Regional Director whenever necessary. The application form is provided in Enclosure No. 1 to this Memorandum.

6. All recommendations should reach the office of the Director, National Research and Development Centre for Teacher Education, Ministry of Education and Culture, Manila, not later than January 24, 1980, for screening and final selection of teaching staff.

7. Teaching at the Baguio Vacation Normal School (BVNS) is a full time job hence, instructors assigned should not seek or accept other employment nor pursue studies during the whole summer term.

8. It is desired that the contents of this Memorandum be given the widest publicity possible.
