EVALUATION OF THE SCHOOL HEALTH GUARDIAN PROGRAM

To: Bureau Directors
Regional Directors
Schools Superintendents
Presidents, State Colleges and Universities

1. An evaluation of the School Health Guardian Program will be conducted to determine areas of effectiveness as well as aspects of its organization that may need modifications. It may be recalled that the Program was launched in 1975 as an integrated and coordinated program of health, nutrition and food production projects, aimed at promoting, maintaining and improving the health and nutritional status of school children.
2. In preparation for the actual evaluation as well as other pre-evaluation activities like data gathering, an orientation will be conducted at the regional level. Participants to this orientation will be five regional and five division supervisors/coordinators involved in the implementation of the School Health Guardian Program selected from among the following: School Health Guardian coordinator, Alay Tania coordinator, Nutrition/Home Economics supervisor, supplementary feeding coordinator (CARF/CRS/WFP), Environmental Education coordinator and a school division medical officer/division dental supervisor/Health Education supervisor to represent health services. To complete the regional/division evaluation team of five members, other supervisors may be included.

The regional directors are requested to make arrangements for the site and facilities needed.

4. Actual transportation expenses and stipends of P25/day of delegates to the orientation will be provided by the School Health and Nutrition Center to be sent in Cash Disbursement Ceiling to the regional offices concerned.

5. The trained evaluators will collect data from all public elementary schools from January to March 1980. Each evaluator will be entitled to a monthly flat allowance ranging from P150 to P300 during the three-month period ending March 31, 1980.
