RATES FOR BOARD AND LODGING IN TEACHERS CAMP  
(BAGUIO) FOR SUMMER 1980

To: Bureau Directors  
Regional Directors  
School Superintendents  
Presidents, State Colleges and Universities

1. The Teachers Camp in Baguio City will be open from April 12 to May 25, 1980, to admit teachers, principals, supervisors, and other school officials attending the vacation classes at the Camp. It will also admit teachers and their guests who merely wish to spend a few days or weeks of vacation in Baguio.
2. The rate for board and lodging in a dormitory at the North Side Mess Area of the Camp for teachers who stay one month or more will be P15 a day, divided into four units consisting of lodging, breakfast, lunch and dinner at P3.75 per unit.
3. For less than one month's stay, the rate will be P20 a day; lodging at P8.00, breakfast at P4.00, lunch at P4.00 and dinner at P4.00.
4. Guests who stay in the Camp for twenty-four (24) hours or less will be charged P22 for board and lodging.
5. The rates for cottage rentals for vacationing families are given in the inclosure to this Memorandum.
6. Accommodations in the Smoking Hall, a dormitory for couples, will be on a first-come-first-served basis. Preference will be given to husbands and wives attending summer classes.
7. For overnight lodging only in a dormitory each guest will be charged P10.
8. Permanent teachers who will attend summer classes at the Baguio Vacation Normal School and whose salaries are paid from the national fund by the Payroll Service Division (PSM), Budget Commission, Manila, or from local funds may pay their board and lodging under the following installment plan: 50% of the total bill to be paid upon registering in the Camp







and the balance to be paid in five (5) monthly installments from August to December 1960. They should bring with them a written recommendation from their district supervisors to avail themselves of the installment plan.

9. Temporary/substitute teachers will have to pay their board and lodging in full upon registering in the Camp.

10. Teachers and guests need not bring beddings. These will be provided by the Camp. However, they must provide themselves with towels and toilet articles.

I. The lodging rates effective January 1, 1980 are as follows:

A. Dormitories

1. Daily rate for teachers ..... ₱ 8.00
2. Daily rate for other guests/lodgers and students 10.00

B. Cottages

1. 2-bedroom cottage (5 beds capacity) with cooking facilities ..... 80.00/day
2. 2-bedroom cottage (5 beds capacity) without cooking facilities ..... 70.00/day
3. 3-bedroom cottage (8 beds capacity) with cooking facilities ..... 100.00/day
4. 3-bedroom cottage (6 beds capacity) without cooking facilities ..... 90.00/day
5. 4-bedroom cottage (10 beds capacity) ..... 120.00/day

II. Reservation for accommodations may be made at the Administration Building, Teachers Camp, Baguio City; Telephone No. 35-17.

III. Guests are requested to check-in at the Camp office during office hours only:

8:00-12:00 a.m.      1:00-5:00 p.m.

The payment of accounts should likewise be made during office hours only.

IV. For the information and guidance of all concerned, below are some regulations being enforced in Teachers Camp:

1. There will be no smoking in the bedrooms.
2. Drinking liquor and gambling are prohibited in the Camp.
3. Guests should look into the safety of their valuables, such as watches, jewelry, cameras, etc. The management will not be responsible for the loss of such articles in the Camp.
4. Water should be conserved. Guests are requested to turn off the faucets which they are using while soaping their faces or hands.
5. Electric lights should be switched off when leaving the rooms or cottages for some time.
6. Cooking, laundering, and ironing of clothes are not allowed in the dormitories. The hanging of clothes outside the windows, should be avoided.
7. Guests, particularly in the dormitories, are requested to minimize noise while the other guests are sleeping or resting.
8. Care should be observed in the use of beddings and facilities provided for by the Camp management.







9. The dormitory or cottage caretaker should be informed in advance of the time of the guests' departure in order that beddings and other properties can be checked and accounted for. Losses or breakages of property will be paid for or replaced by the guests concerned.
10. Guests should obtain their clearance from the Office which in turn will be presented to the cottage/dormitory caretaker before departure.
11. The anti-littering ordinance is strictly enforced in the Camp and in the City of Baguio. Guests are requested to make use of the trash boxes.
