1980 PHILIPPINE NATIONAL RED CROSS MEMBERSHIP AND FUND DRIVE

To: Bureau Directors

1. Proclamation No. 1822 of the Office of the President authorizes the Philippine National Red Cross to conduct its membership and fund campaign from January 15 to August 31 every year. The Proclamation enjoins all citizens and residents of the Philippines, irrespective of nationality or creed, to give generously to and participate actively in this humanitarian endeavor.

2. The Proclamation likewise authorizes all national and local officials to accept fund-raising responsibilities, take the initiative and assume active leadership in the PNRC fund campaign in their respective communities.

3. This Office strongly endorses this campaign and enjoins all officials and employees of the Ministry of Education and Culture, including school officials and teachers in the field, as well as school children and students to give their full support and cooperation to this campaign.

4. Immediate dissemination of this Memorandum is desired.

PROCLAMATION NO. 1822

PROCLAIMING THE NATIONWIDE MEMBERSHIP AND FUND CAMPAIGN
OF THE PHILIPPINE NATIONAL RED CROSS FOR THE YEAR
1979 AND EVERY YEAR THEREAFTER.

WHEREAS, under Presidential Decree No. 1264 dated December 15, 1977, the Philippine National Red Cross is the duly constituted voluntary organization officially designated to assist the Republic of the Philippines in discharging the obligations set forth in the Geneva Conventions and to perform such other duties as are incumbent upon a National Red Cross Society;

WHEREAS, in the 32 years of its existence as a National Society, the Philippine National Red Cross has proved an effective auxiliary to the government in the field of relief, health and welfare;


WHEREAS, the aforesaid Decree directs that the Philippine National Red Cross shall be financed primarily by contributions obtained through solicitation campaigns throughout the year;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by law, do hereby proclaim the nationwide membership and fund campaign of the Philippine National Red Cross for the year 1979 and every year thereafter;

I hereby enjoin all citizens and residents of the Philippines, irrespective of nationality or creed, to give generously and participate in this humanitarian endeavor.

All national and local officials are hereby authorized to accept fund raising responsibilities and take the initiative and assume active leadership in the Red Cross membership and fund campaign in their respective communities.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.




