RECOUNTION OF PHILIPPINE QUALIFICATIONS IN AUSTRALIA

I refer to your letter of 10 July 1979 concerning recognition of Philippine educational qualifications in Australia, particularly those awarded in the professional field of teaching.

In Australia employing authorities and educational institutions are autonomous and make their own decisions on the acceptability of overseas qualifications including those awarded by Philippine institutions for employment or enrolment purposes. The role of this Department in evaluating overseas educational qualifications is to provide an advisory service in the assessment of overseas qualfifications for the government departments, educational institutions and employing authorities which have responsibility for assessing overseas qualifications.

The approach followed by our Department in the evaluation of overseas educational qualifications including those from the Philippines is to consider each case on its individual merits. The main criteria adopted in assessing overseas qualifications include the status of the insti-

tution, the overall duration of formal studies completed, the admission requirements, the level of
formal studies reached, the marks awarded, the subjects
studied and length and depth of study in each subject.
We do not have a selected list of accepted Philippine
institutions but we, of course, take into account
whether the institution in question has been recognised
by the Philippine Government.

One of the main criteria used in assessing tertiary qualifications from the Philippines against Australian qualifications is the number of years of formal study involved. As the education system in the Philippines comprises a total of ten years of primary and secondary schooling compared with twelve to thirteen in Australia depending on the State, it would seem that a high school graduate from the Philippines could not be considered to have reached the same level as an Australian matriculant. At the tertiary level therefore Australian authorities do not normally consider a four-year first degree from the Philippines as comparable in standard to an Australian degree, although the assessment in each case would also take into account other criteria mentioned above, such as the institution attended and the level of marks awarded.

It is understood that in the professional field of teaching Australian teacher employing authorities including State education departments generally require teachers from the Philippines to hold a master's degree, eg Master of Education, Master of Arts in Education, Master of Arts in Teaching before they would be considered acceptable by Australian standards.

Teachers qualified in the Philippines who wish to teach in Australia are advised to contact Australian teacher employing authorities to establish whether their qualifications are acceptable. If an assessment is needed the teaching authority would contact the Committee on Overseas Qualifications (COPQ) which, through its expert panel in teaching makes assessments on overseas teaching qualifications.
