THIRD ANNUAL CONVENTION-WORKSHOP OF THE PHILIPPINE VOCATIONAL GUIDANCE ASSOCIATION OF THE PHILIPPINES

To: Bureau Directors
Regional Directors
Presidents, State Colleges and Universities
Heads of Private Schools, Colleges
and Universities

- 1. The Philippine Vocational Guidance Association (PVGA), in coordination with the Ministry of Education and Culture, and in cooperation with the Federation of Batarisan Implementors, the National Manpower and Youth Council and the Fund for Assistance to Private Education will hold its third annual convention at the Manila Mandarin, Makati Avenue, Makati, on May 5-6, 1980.
- 2. Cognizant of the need for a workable program where the school and the employment sectors could work together in the manpower development and in the implementation of Letter of Instructions No. 740, requiring all private companies, firms and entities to participate in the Batarisan Program, the PVGA has adopted the theme: "The Education and Employment Sectors as Co-Partners in Manpower Development." The objective of the convention-workshop is: to explore possibilities for an operational relationship between the school and employment sectors by:
 - a. determining the manpower skills needed by Philippine industries so that curriculum educators could infuse them into the schools;
 - discussing the roles which the school and the industry can contribute in manpower development and in the success of the Batarisan Program;
 - c. providing the participants with enough background for designing guidance programs relevant to the needs of their set-up; and
 - d. initiating action plans to enhance effective relationship between the school and employment sectors.

- 3 All heads of schools, colleges and universities are enjoined to send their guidance counselors and chairman of their Curriculum Committee as delegates to the convention Attendance is on official time
- The convention-workshop fire of \$\mathbb{F}^00\$ for PVGA members and \$\mathbb{P}^250\$ for non-PVGA members, include a convention kit, handouts, a cellificate and lunch for two days. Expenses incurred by the participants shall be personal in the case of government employees. Expenses of participants from private educational institutions may be borne by their respective schools.
