10TH WORLD CONGRESS ON EDUCATIONAL AND VOCATIONAL GUIDANCE

1. The Philippines is hosting the 10th World Congress of the International Association of Educational and Vocational Guidance (IAEVG) on the theme: "A Collaborative Approach to Guidance Services for Career Development." This will be held on September 1-5, 1980 at the Philippine International Convention Center (PICC), Manila.
2. The Congress is being sponsored by the Asian Regional Association for Vocational and Educational Guidance (ARAVEG), the Philippine Association for Career Guidance and Development (PHICGUIDE), and non-profit, non-political, governmental and non-governmental organizations and individuals involved in educational and vocational guidance throughout the world.
3. The objectives of the Congress are (a) to strengthen the understanding and cooperation of the people concerned through mutual assistance and exchange of information and experience among governmental and non-governmental organizations and individuals participating in the work of educational and vocational guidance and (b) to promote this type of work and manpower development in member countries, thus contributing to the prosperity, welfare and peace of the world. Inclosed is the program of activities and the areas for discussion in the Congress.
4. In view of the crucial role that educational and vocational guidance plays in the modern world's aspirations for more rational and effective living, we hope to generate as much local and foreign participation as possible. The following local representatives are invited to participate.
  - a. Guidance supervisors in the secondary and tertiary levels of public and private educational institutions;

- b. Staff and faculty members of technical and vocational schools who are involved in guidance and career development; and
- c. Administrators of these schools.

5. Participants from public schools and other government institutions may attend the Congress on official time only. Institutions not covered by LOI No. 981 may formulate their own policies regarding the attendance of their representatives in the Congress.

6. Registration fee for participants who are members is ₱450; for non-members - ₱600. This entitles the participants to attend all plenary and concurrent sessions, receptions and tours, conference kits, and to certificates of participation. Those who wish to attend the plenary and concurrent sessions only may register as observers and pay ₱200 (for members) or ₱250 (for non-members).

7. In our commitment to project a positive image of our country during this Congress, it is requested that full-hearted support be extended to this undertaking. It is also desired that the contents of this Memorandum be disseminated immediately for the information and guidance of all concerned.

## OTHER INFORMATION

### ARRIVAL PROCEDURE:

Upon arrival, debarking passengers will be ushered into the "Arrivals" section of the Manila International Airport. Immigration officials will check passports, visas, and onward passage. The next step is the luggage receiving area where customs officers will check luggage prior to leaving the customs area.

Congress Secretariat representatives will be on hand to assist delegates traveling in groups, as well as individuals who have informed the Secretariat in advance of their exact flight arrival details.

If the participant should decide to stay longer than 21 days for further tours or other purposes, the Congress Secretariat can help secure a visa extension from the Bureau of Immigration. Tourist visas issued abroad are usually good for an extendable single entry of from 59 days to 12 months.

### IDENTIFICATION TAGS:

Participants from abroad who have registered in advance will be provided with identification tags. These tags should be worn upon arrival at the Manila International Airport to facilitate their identification by Congress Secretariat representatives.

Special Congress luggage tags will also be provided to facilitate luggage processing through customs.

### HOTEL TRANSFER:

Transportation to the hotels will be arranged for participants who have informed the Congress Secretariat in advance of their airport arrival.
