> REVISED COMPOSITION OF MEMBERSHIP IN NATIONAL SCHOLARSHIP CENTER COORDINATING UNITS IN MEC FIELD OFFICES

To: Bureau Directors Regional Directors

- 1. In line with the government's thrust towards regionalization, the composition of the Coordinating Unit in the regional/
 provincial/city offices as given in Unnumbered Memorandum dated
 February 13, 1978 and MEC Memorandum No. 7, s. 1979, is hereby
 smended such that its chairman shall come from the field office
 and no longer the representative of the National Scholarship
 Center. Thus, all three members of the Unit located in a provincial capital, which is the seat of the regional office, shall be
 designated by the regional director. On the other hand, for a Coordinating Unit located in the province/city which is not the seat of
 the regional office, the regional director shall designate its
 coordinators upon recommendation by provincial/city superintendent
 concerned.
- This revised composition of three members per Coordinating Unit shall be applicable only in the ten areas with the most number of awardees; namely: Cotabato City, Davao City, Zamboanga City, Cebu City, Marawi City, Baguio City; Iloilo City, Jolo, Silu, Kalinga-Apayao and La Trinidad, Benguet, as originally established.
- 3. In the case of Cotabato City and Zamboanga City, where the administration of the state scholarship and study grant programs has been regionalized effective school year 1980-1981, the newly created Regional Office Scholarship Unit shall act and perform the functions of the Coordinating Unit.
- 4. For the additional number of Coordinating Units, however, as stated in Unnumbered Memorandum dated March 19, 1980; only one Coordinator shall be designated who, at the same time, shall act as chairman of the Unit owing to the insignificant number of clientele being currently serviced.

- 5. Inasmuch as the number of grantees/awardees under the management of the different units fluctuates semestrally/yearly, the number of coordinators to be designated may likewise be increased/decreased as determined by the National Scholarship Center.
- 6. It is understood that members of the NSC Coordinating Units are entitled to a monthly honorarium of Ploo, subject to future increases in accordance with availability of funds.
- 7_{\bullet} Immediate compliance with the contents of this Memorandum is hereby enjoined.
