Dear Minister Corpuz:

This has reference to your memorandum of May 27, 1980 requesting exemption of public schools from the provisions of National Budget Memorandum No. 13, dated February 28, 1980 in relation to Letter of Instructions No. 981 which provides that "New position items created in CY 1980 shall not be filled, except for hospitals."

Pursuant to the provisions of LOI No. 29, this Office will interpose no objection to the above request provided that in filling said new positions, priority shall be given to itemless teachers and those who were earlier appointed as extension teachers and paid from local school board funds. New appointees shall be given itemized positions only when all the itemless teachers and local school board appointees have been given teaching positions items and Provided, Further, That vacant positions shall not be filled in those school divisions declared to have positions in excess of those justified by actual enrolment.
