1981-1982 TEACHER TRAINING PROGRAM IN SPECIAL EDUCATION

To: Bureau Directors Regional Directors Chiefs of Services and Heads of Units Presidents, State Colleges and Universities Schools Superintendents

- The training program for teachers, administrators and supervisors in Special Education for the SY 1981-1982 at the University of the Philippines and the Philippine Normal College is hereby announced by the Scholarship Committee of the Ministry.
- The training grant for administrators, coordinators and supervisors of special education shall be for a period of two (2) summers and a practicum of ten (10) weeks following the second summer while that for teachers shall last for one (I) summer and two (2) semesters. This training program will lead to a certificate of proficiency and possibly a master's degree in any of the following areas:
  - a. Organization, Administration and Supervision of Special Education (OAS)
  - b. Education of the Mentally Cifted/Fast Learners
  - c. Education of the Mentally Retarded/Slow Learners
  - d. Education of the Visually Impaired
  - e. Education of the Hearing Impaired
  - f. Education of Children with Behavior Problem/ Emotional Disturbances
- Each division may nominate three candidates for each area of specialization most needed in the division. The screening committee of the Regional Office will in turn screen these candidates so that only the most competent ones will be referred to the Researchers of the Special Education Division, Bureau of Elementary Education, who will interview and administer tests in the following screening centers:

4. Teacher-applicants for the training program must meet the following requirements:

- a. Educational Qualification B.S.E., B.S.E.ED or its equivalent.
- b. Civil Service Eligibility Teacher.
- c. Ferformance Rating Very Satisfactory for the last three years.
- d. Scholastic Ability Weighted Average of not lower than B or 2 or its equivalent.
- e. Experience Teacher must actually be handling classes, on permanent status, and has at least three (3) years of successful teaching experience with normal children.
- f. Health Must be emotionally stable and physically fit as indicated in a health certificate duly accomplished by a government physician, including a frog test (to be submitted before enrolment) for married women. There shall be no deferment or maternity leave within the stipulated scholarship period.
- g. Special Qualification Must have a genuine interest in and dedication to the welfare of exceptional children with qualities of leadership.

- h. Age The teacher nominee should not be more than 40 years old. CAS nominee should not be more than 50 years old.
- i. Status and Sex Single teachers are preferred; male recommendees needed for teachers for the blind.
- j. The numinees must not have any pending administrative
- k. The nominee should not have been a recipient of any scholarship or training grant within the last five (5) years before this nomination.
- 5. Each grantee will be entitled to the following privileges:
  - a. Study leave with pay for the duration of the training;

b. Free tuition and other fees;

- c. Book allowance of P300 for the whole year;
- d. Monthly stipend of P300 during the period of training; and
- e. Transportation expenses to Manila and return to be charged against local funds.
- 6. Three copies of each of the following requirements must be submitted by each candidate to the MEC Screening Committee during the interview:
  - a. Letter of recommendation from the provincial/city schools.superintendent.
  - b. Information Sheet (Inclosure No. 1) duly accomplished and certified to by the head of agency or office.
  - c. Original copy of Transcript of Records and three (3) xerox copies of the same.
  - d. Scholarship Agreement signed by the nominee and the provincial/city superintendent/the head of agency or institution, duly subscribed and sworn to. (Inclosures Nos. 2 & 3)
  - e. Health certificate (Form 211) duly accomplished by a government physician.
  - f. Performance rating for the last three years duly certified.
  - g. Clearance from any obligation or pending administrative case by the division administrative officer or head of agency or office.

- h. Recent photograph size  $2^{\text{m}}$  x  $2^{\text{m}}$  to be attached to the information sheet (Form I).

- 7. Funds for this program will be charged against the appropriations provided for in the MEC Integrated Scholarship Fund and R.A. No. 3562 entitled "An Act to Promote the Education of the Blind in the Philippines".
