RECRUITMENT OF BVNS FACULTY STAFF FOR 1981 SUPPER CLASSES

To: Bureau Directors
Regional Directors
Chiefs of Services and Heads of Units

- 1. The 1981 Baguio Vacation Normal School (BVNS)
  Teacher Education Summer Classes will offer undergraduate,
  graduate and special leadership/seminar courses for teachers and other school officials in all levels at the Teachers
  Camp, Baguio City, from April 13 to May 23.
- 2. As a component of the MEC Staff Development Program, the BVNS is envisioned as a cooperative enterprise among the different MEC agencies. Along this context, the bureau and regional directors, and other officials of the Ministry are enjoined to take part in the recruitment of faculty staff for this year's summer operation. Applicants who have efficiently served at the BVNS as well as qualified and competent educators who meet the necessary qualifications called for in the succeeding paragraph may be recommended.
- 3. The recommendee should have at least a master's degree and preferably should hold a doctoral degree in his field of specialization. He should have taught in his major field for at least five (5) years, possess high leadership potential, should have good mental and physical health. Only in cases where the applicant has a high degree of expertise and when no other recommendee is qualified may any of these requirements be waived.
- 4. The following are the fields of specialization where the services of faculty staff will be needed: Science, Mathematics, Social Studies, Communication Arts (English or Pilipino), Educational Administration and Supervision, Adult Education, Functional Literacy, Guidance and Counseling,

Educational Media, Pre-Elementary Education, School Health Education, Home Economics, Music and Physical Education and Development Communication.

- 5. All applications should be accompanied by official Transcript of Records, duly accomplished health certificate (General Form 86) properly indorsed by the city or provincial schools superintendents or heads of office or agency concerned and approved by their respective regional directors whenever necessary. The application form is inclosed with this Memorandum.
- 6. All recommendations should reach the Office of the Director, National Research and Development Centre for Teacher Education, Ministry of Education and Culture, Manila, not later than January 31, 1981 for screening and final selection of BVNS faculty staff.
- 7. Teaching at the BVNS is a full time job, hence, instructors assigned should not seek or accept other employment nor pursue studies during the summer term.
- 8. It is desired that the contents of this Memorandum be given the widest publicity possible.
