1. In support of the government thrusts in human resources development and to promote further the democratization of educational opportunities to poor but deserving students through financial assistance, a Seminar-Workshop on Human Resources Development in the 80s through the "Study Now Pay Later Plan" will be conducted by the National Educational Loan Assistance Center, Ministry of Education and Culture, in cooperation with the five lending institutions, namely: the GSIS, SSS, PNB, DBP, and LBP, together with the Ministry of Labor and Employment, Personnel Management Association of the Philippines and National Manapower and Youth Council, at the following designated dates and places:

The objectives of the seminar-workshop are the following:

a. Provide and develop an awareness of the emerging issues in human resources development in the 80s.

b. Develop better employment opportunities here and abroad for the "Study Now Pay Later Plan" graduates of the 80s.

c. Strengthen the career development program in labor, business and industries for the SNPLP graduates of the 80s.

d. Thresh out and adopt remedial measures and/or solutions to problems encountered by the SNPLP coordinators involved in the educational loan assistance program.

e. Strengthen the role of the SNPLP coordinators in the effective implementation and prosecution of the educational loan assistance program.

f. Assess/Evaluate the educational loan assistance program from school year 1976-1977 to the present.

Form 86) duly signed by a government physician attesting to their being physically fit should be submitted to the National Educational Loan Assistance Center, Ministry of Education and Culture, Manila, on or before January 30, 1981.
- 5. The MEC regional participants are requested to bring the following:
 - a. List of suggested priority courses for their respective regions and schools;
 - b. Brief narrative status report on the implementation of the Study Now Pay Later Plan covering the SY 1976-1977 to the present in their regions;
 - c. Action plan for each region, and
 - d. Problems encountered and suggested solutions.
- 6. Each regional/division participant is entitled to reimbursement of travelling expenses incident to this seminar-workshop which are chargeable against local funds. Likewise, an amount of one hundred fifty pesos (F150) is charged each participant for the board and lodging fee. Expenses incurred by each participant from the MEC proper are chargeable against the funds of the National Educational Loan Assistance Center. All such expenses are subject to the usual accounting and auditing regulations.
- 7. Inclosed is a tentative schedule of activities of the seminar-workshop.
- 8. All officials concerned are enjoined to give preferential attention to this matter.
