> AUTHORIZING THE PHILIPPINE TUBERCULOSIS SOCIETY TO CONDUCT THE 1981 NATIONAL EDUCATIONAL AND FUND CAMPAIGN

TO Bureau Directors Regional Directors Presidents, state Colleges and Universities School Superintendents Heads of Private Schools, Colleges and Universities

- Inclosed is Proclamation No 2048 of His Excellency, President Ferdinand E Marcos, dated January 27, 1981, authorizing the Philippine Tuberculosis Society, Inc to conduct a national educational and fund campaign from January 2 to December 31, 1981,
- The Proclamation specifically calls upon all citizens and residents of the Philippines regardless of race and creed "to support actively and give generously of their time and resources to the Anti-TB cause, so as to hasten the control of this debilitating diseases, minimize human suffering among the afflicted, and promote national strength and prosperity through a healthy citizenry free from the dangers of the disease "
- Since the Proclamation allows solicitation of contributions for a worthy cause and in view of the improved and effective fight against tuberculosis through domiculiary visits especially in the rural and/or overcrowed areas, this Office strongly endorses this fund campaign. It is requested that all efforts be exerted to the end that school officials, teachers, faculty members, students, pupils, and other school personnel give liberally to the Society
- Remittances from each superintendent or school shall be in check or money order drawn in favor of the Philippine Tuberculosis Society, Inc (1981 Fund Campaign) and transmitted to the Regional Office, c/o the Regional Director who, in turn, shall transmit said check and/or money order to the Ministry of Education and Culture, c/o Deputy Minister Hermenegildo C Dumlao, Campaign Chairman In every case, the transmittal letter should indicate in summary form the sources of the collection to enable the Educational Institutions Division of the Philippine Tuberculosis Society, Inc. to keep tab of the progress of the campaign and determine the extent of compliance of all concerned
- To avoid overlapping in the campaign effort of all participating agencies, it should be understood that donations to the 1981 Anti-TB Fund Campaign raised from Educational Institutions Division shall not be claimed by any of the fund campaign unit as part of the over-all collection of a province or city notwithstanding the fact that a school superintendent or a school head may be a member of any of the provincial or city fund campaign committees
- It is desired that this Memorandum be brought to the attention of all concerned for their information and guidance and that appropriate steps be taken

## PROCLAMATION NO 2048

AUTHORIZING THE PHILIPPINE TUBERCUIOSIS SOCIETY, INC TO CONDUCT A NATIONAL EDUCATIONAL AND FUND CAMPAIGN DURING THE PERIOD FROM JANUARY 2 TO DECEMBER 31, 1981, AND EVERY YEAR THEREAFTER

WHEREAS, the Philippine Tuberculosis Society, Inc. complements and supports the government's National TB Control Program, aimed at controlling tuberculosis, one of the leading causes of death in the country.

WHEREAS, the Philippine Tuberculosis Society, Inc. in undertaking its prevention, treatment and health education activities, seeks to eliminate tuberculosis as a major obstacle to the physical, social and economic well-being of our people,

WHEREAS, the Philippine Tuberculosis Society, Inc. has expanded its domiciliary and dispensary programs in order to bring the benefit of its services to more areas, and to a bigger number of people,

WHEREAS, the Philippine Tuberculosis Society, Inc. can achieve its humanitarian objectives only with the participation and involvement of the community, and

WHEREAS, the attainment of the humanitarian objectives of the Philippine Tuberculosis Society, Inc. will redound to the health and welfare of every Filipino.

NOW, THEREFORE, I, FERDINAND E MARCOS, President of the Philippines, by virtue of the powers vested in me by law, do hereby authorize the Philippine Tuberculosis Society, Inc. to conduct a national educational and fund campaign during the period from January 2 to December 31, 1981, and every year thereafter

I call upon all c tizens and residents of the Philippines, regardless of race or creed, to support actively, and give generously of their time and resources to the anti-TB causes, so as to hasten the control of this debilitating disease, minimize human suffering among the afflicted, and promote national strength and prosperity through a health citizenry free from the dangers of the disease.

It is hereby resterated that all donations and contributions to the fund campaign and its various projects and activities shall be exempt from income, gift, amusement and all other taxes, and the same shall constitute allowable deductions in full from the income for purposes of computing the maximum amount deductible under Section 30, paragraph (h), of the National Internal Revenue Code, as amended

To enable the Philippine Tuberculosis Society to use its full resources in the fight against tuberculosis, I hereby decree that all its income from whatever sources shall be tax-evenpt

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Ropublic of the Philippines to be affixed

Done in the City of Manila, this 27th day of January in the year of Our Lord, nineteen hundred and city one.
